\*S6M-08428 Mark Griffin: Older Adult Unpaid Carers—That the Parliament welcomes the launch of Experiences of Older Adult Unpaid Carers in Scotland, a research report by Carers Trust Scotland, and the coming together to recognise the impact of unpaid caring on adults over 65 across Scotland; further welcomes the research launch event taking place on 29 March 2023; values what it sees as the significant and vital contribution of older adult unpaid carers, and of carer service support workers; considers that there is a wide range of challenges facing this group of unpaid carers; notes that 80% of older adult unpaid carers that responded to the survey said that their physical health had been affected by their caring role, and 87% said that their mental health and wellbeing had been affected; acknowledges that Carers Trust Scotland will share its recommendations and suggestions to support older adult unpaid carers by strengthening provision for carer services; understands that, due to Scotland's ageing population, the future of unpaid care across the country will become increasingly pertinent to older adult unpaid carers; recognises what it sees as the important role that they play, and believes that every effort should be made to support the implementation of the report's recommendations, and to continue to support older adult unpaid carers and carer service works.

\*S6M-08392 Claire Baker: Congratulating West Plean and Auchenbowie Ladies Club on Centenary and Raising Funds for Forth Valley Sensory Centre—That the Parliament congratulates West Plean and Auchenbowie Ladies Club on marking its centenary and raising funds for Forth Valley Sensory Centre; understands that the group was set up in 1923 by the Bolton's of West Plean House, and the Munro's of Auchenbowie House, near Stirling, to support the women of the district's farming community; notes that they marked the occasion by handing over a cheque for £175 to Forth Valley Sensory Centre to support British Sign Language; further notes that members of the group have met regularly, helping to provide services from their own resources, as well as receiving useful information on health and domestic issues; understands that, over the years, they have gone on excursions, and run helping hands projects to look after poorer and infirm neighbours; further understands that, before the Second World War, they raised funds towards the cost of the then new Stirling Royal Infirmary, supplying sheets, and for many years eggs from their own hens; believes that with fewer agricultural workers locally the membership changed, but the club remains active, with 48 members at present, and continues to meet every month in Larbert Old Church; recognises what it sees as the valuable contribution of the group to the local area over the years, and extends its very best wishes for the future.

\*S6M-08391 Martin Whitfield: Keep the Heid Mental Health Cafés—That the Parliament notes the success of the Keep the Heid mental health cafés in Haddington and Tranent; further notes the publication of an independent evaluation report of the first café in Haddington, which started in November 2021; understands that the report details the positive impact the café is making on those who access the service and highlights the various benefits they reported having gained from it, which include improved self-confidence, reduced isolation and new friendships, increased resilience, greater structure and purpose, enhanced interest and participation in other community-based support networks, practical help through information sharing and general feelings of comfort and support; further understands that one of the project's key ambitions is to expand the service into other communities, including Midlothian; notes that a pilot café, funded by the North Berwick Trust, in partnership with North Berwick Coastal Community Connections, will begin in April 2023; commends everyone involved in establishing, running and expanding the Keep the Heid mental health cafés for their innovative approach to supporting people with their mental health, and wishes the project every success in the future.
