### Debate on the subject of-

<u>S6M-08579</u> Bill Kidd: Firefighters' Memorial Day 2023—That the Parliament recognises 4 May as International Firefighters' Day (IFFD), which is also known as Firefighters' Memorial Day, and is an annual observance to honour the sacrifice of firefighters who have lost their lives in the line of duty; thanks firefighters serving communities across Scotland, including the crew at Knightswood Fire Station in Glasgow Anniesland, for their tremendous contribution in ensuring people's safety; acknowledges the courage and dedication of generations of firefighters; understands that the Scottish Fire and Rescue Service is the fourth largest serving firefighting force in the world; remembers and honours the firefighters who have sacrificed their lives in the line of duty; understands that a minute's silence will take place at 12 noon on 4 May 2023, on the forecourts of fire stations and other fire and rescue workplaces; notes the work of the Fire Brigades Union in its Red Plague project and DECON campaign; further notes the view that all fire stations should have safe work practices, including full decontamination facilities, to ensure that firefighters and their families are not exposed to harmful particles; notes the classification by the World Health Organization's International Agency for Research on Cancer, in July 2022, of the occupational exposure of firefighters as carcinogenic to humans, which increases the likelihood of cancer, and notes the view that this classification has made health and safety measures even more important.

#### Members' Business motions that have not achieved cross party support

\*S6M-08744 David Torrance: Work Set to Commence in Fife on Green Hydrogen Gas Network—That the Parliament welcomes the upcoming launch of the Levenmouth H100 Fife hydrogen network; understands that the project will start in May 2023, last for 15 months, and will be carried out in five phases; further understands that, by using clean offshore wind power and a dedicated green hydrogen production facility, the new gas network will deliver clean heat to around 300 households; acknowledges that the H100 project is a world-first green hydrogen gas network in the Buckhaven and Denbeath areas of Levenmouth, Fife; believes that the H100 project is leading the way in decarbonising home heating, and will be the first 100% hydrogen-to-homes zero carbon network anywhere in the world, demonstrating what it sees as the potential for the whole British gas network to deliver hydrogen gas; notes that the H100 project will be undertaken by gas distribution company, SGN, and is funded by the Scottish Government, Ofgem, SGN, and Northern Gas Networks, among others; commends SGN and its funders for the £32 million project and investing in Fife's green energy industry, and wishes the project all the very best in its implementation.

\*S6M-08735 Fulton MacGregor: One Parent Families Scotland's End Young Parent Poverty Campaign—That the Parliament recognises the commencement of One Parent Families Scotland's End Young Parent Poverty campaign, which began on 26 April 2023; notes with concern reports that people aged under 25 receive less than older Universal Credit claimants in the same circumstances; believes that such a policy disproportionately affects parents who are under 25, including in the Coatbridge and Chryston constituency; acknowledges reports that, in real terms, this means that couple parents under 25 lose out by £100 per month compared to over-25s, and single parents under 25 lose out by £65 per month compared with those over 25; notes the calls for the Scottish Government to support young families with a top-up to the Scottish Child Payment for parents under 25, who are in receipt of Universal Credit; further notes the calls for the UK Government to urgently reverse what it considers this discriminatory policy and pay under-25s the same rate of benefits as over-25s; understands that the campaign is supported by nearly 50 partner organisations, and notes the view that the realisation of the campaign's goals will help children at the highest risk of poverty, promote gender equality by addressing what it sees

as the deep inequalities faced by young single parents who are disproportionally female, as well as supporting all young single parent families who represent the household type reportedly most likely to lose out from the move to Universal Credit, and help Keep The Promise to care experienced young people.

#### Other new and altered motions and amendments

\*S6M-08821 Annie Wells: Glasgow Street to Celebrate the Coronation and Raise Money for the British Red Cross—That the Parliament congratulates Kirsteen Oliver, a stallholder at the farmers market in Partick, along with neighbours, for organising a street party to celebrate the Coronation while raising money for the British Red Cross; understands that the event for the community in Nottingham Avenue, in the Kelvindale area, will take place on 7 May 2023; notes that, while the occasion is The King's Coronation, the event is more about holding a community gathering; understands that it will be the fourth time that a community party has been held on the street, with previous street parties having been held for The Queen's Platinum Jubilee, Golden Jubilee and the Commonwealth Games; recognises that residents in the surrounding streets have also been invited to attend, with around 80 adults and children expected; notes that people are being asked to bring their own chairs and food, making it a community effort; acknowledges that the neighbours will gather for a short opening ceremony and ribbon cutting at the food tent. followed by food and drinks, a treasure hunt, races and a raffle; understands that Maryhill community police officers will also be in attendance, showing children around the police car; notes that neighbours have volunteered to do face painting and nail painting, while others will bring play equipment for children to play on in the street, and understands that money has been raised through donations to pay for any costs, and that the remaining money will be donated to the British Red Cross.

\*S6M-08817 Alexander Stewart: Paying Tribute to the Second World War Codebreaker, Adelina Ferguson—That the Parliament pays tribute to the resident of Bield Sheltered Housing in Bridge of Allan, and Second World War veteran, Adelina "Lena" Ferguson, nee Irvine, who sadly passed away on 23 April 2023, aged 103; understands that she was part of the Allied codebreaking operation, starting work as a cryptographer at Bletchley Park, Milton Keynes, aged 24; notes that she moved to Bridge of Allan aged 99 from her home in Jordanhill in the west end of Glasgow, where she had lived for most of her life, to be closer to family; understands that she was a much-loved mother, grandmother and great grandmother, and had a happy marriage to James Ferguson from 1948 until he passed away in 2002; acknowledges that Adelina's brother, George, was a pilot during the Second World War and was shot down over Normandy in 1940, aged 21, and is buried in France; understands that Adelina, a member of the Women's Royal Naval Service, known as the Wrens, was at Bletchley Park for two years, and that, according to her family, was excited to be part of the war effort; notes that, although due to signing the Official Secrets Act, she did not speak in detail about her experiences, she did speak fondly of the Nissen huts that she stayed in with the other Wrens, including when one hut was bombed curtailing all hot water for a week in winter, and also about "whirring drums that would produce letters" and the "huge Colossus machine", as well as modestly referring to herself as "one little part in the many processes that went on"; commends Adelina for her selfless service to the UK's war effort, for which she received a medal and certificate in recognition years later, and sends its sincerest condolences to her surviving family.

- \*S6M-08776 Clare Adamson: International Men's Health Week 2023—That the Parliament notes that International Men's Health Week takes place from 12 to 18 June 2023; understands that the week focuses not only on physical health, but also on men's mental health and emotional wellbeing; further understands that the overall aims of the week are to heighten awareness of preventable health problems for males of all ages, support men and boys to engage in a healthier lifestyle and encourage early detection and treatment of physical and mental health issues, and commends the organisations and peer support groups that are raising awareness and encouraging males to have their annual "Man MOT" and to open up about their emotions and feelings.
- \*S6M-08774 Clare Adamson: World Inflammatory Bowel Disease Day—That the Parliament notes that World Inflammatory Bowel Disease (IBD) Day, which unites people across the globe affected by Crohn's disease and ulcerative colitis, takes place on 19 May 2023; understands that over 50,000 people in Scotland live with IBD, and that it can affect every part of their life both physically and mentally; welcomes the Scottish Government's campaign to raise awareness of IBD, as part of the Modernising Patient Pathways Programme from the Centre of Sustainable Delivery, which aims to provide the right care and tailored treatment, while also leading the rest of the UK on raising public awareness of IBD; acknowledges that IBD is an invisible illness that many people struggle to cope with, and thanks all of the organisations that bring about public awareness and support those who live with IBD.
- \*S6M-08773 Clare Adamson: Mental Health Awareness Week—That the Parliament notes that 15 to 21 May 2023 is Mental Health Awareness Week; recognises what it sees as the relevance of the 2023 theme of anxiety, which, it understands, is a normal emotion that can sometimes become so overwhelming that it becomes a mental health problem; notes that anxiety is one of the most common mental health problems, with a quarter of adults reportedly stating that anxiety has dramatically impacted on their life; believes that Mental Health Awareness Week increases people's awareness and understanding of anxiety, allows people to explore coping methods and helps to remove the stigma that still surrounds mental health, and commends the work of the Mental Health Foundation and local mental health organisations and volunteers across Scotland, who provide mental health awareness and support to those in crisis.
