Members' Business motions that have achieved cross party support

*S6M-11352 Sue Webber: Charitable Hospice Care to Meet Future Need—That the Parliament thanks charitable hospices, across both adult and children's services, for providing vital palliative and end of life care and bereavement support to an estimated 21,000 people in Scotland in 2022-23; commends the care that they deliver, which reaches out into communities and people's homes, through services such as hospice care at home, supporting not only patients but also their families and loved ones; understands that demand for palliative care is predicted to increase by 20% by 2040, and that the care that people need will be more complex; further understands that around 8,200 people die in poverty every year in Scotland; considers that people impacted by poverty face barriers in accessing hospice care; believes that everyone should have access to hospice care if they require it; considers that hospice care reduces pressure on NHS services by supporting people to stay at home and avoid unnecessary hospital admissions; notes reports that unscheduled care costs the NHS £190 million per year for those in the last year of life; understands that the use of unscheduled care services by those in the last year of life in the most deprived areas of Scotland is almost double that of those in the least deprived areas; welcomes that charitable hospices work in partnership with colleagues in the NHS and across the health and care sector; understands with concern, however, that the impact of matching the recent NHS pay awards, alongside rising running costs, is expected to leave the hospice care sector £16 million in deficit in 2023-24, meaning that hospices may need to make tough decisions about the services that they can provide to patients and families in the future, and notes the belief, therefore, that a new national funding framework for hospice care is vital to ensure the ongoing sustainability of the sector and to allow charitable hospices to continue to support the NHS and provide high-quality palliative care to people in the Lothian region and across Scotland.

*S6M-11319 Kenneth Gibson: Lifting the £50 Million Charity Cap—That the Parliament acknowledges the incredible amount of money raised by charity lotteries in the UK, including the Scotland-based People's Postcode Lottery, the players of which have raised what it sees as a phenomenal £1.2 billion for good causes across the country; understands that the demand for funding from charities has greatly increased amid the cost of living crisis and the aftermath of the

COVID-19 pandemic; believes that the current £50 million cap on annual charity lottery sales serves no purpose, and that it is impacting the ability of charity lotteries to increase the amount of funding that they can provide to charities and good causes; notes the view that charities, including those in the Cunninghame North constituency, will continue to miss out on millions of pounds of funding so long as the sales cap remains in place, and further notes the calls for the UK Government to remove the charity lottery annual sales limit as a matter of urgency so that charities across the country are not missing out on vital funding when they need it most.

Members' Business motions that have not achieved cross party support

*S6M-11367 Beatrice Wishart: Future Island and Rural Transport Infrastructure —That the Parliament acknowledges what it sees as the importance of connectivity in Scotland's rural and island areas; recognises Scotland's net zero targets, which were voted for by the Parliament; notes the reportedly high output of carbon emissions from ferries serving Scotland's islands; believes that reliable transport infrastructure is essential for local communities, providing social and cultural benefits, as well as underpinning local economies and tourism; notes the recommendation of the second Strategic Transport Projects Review (STPR2) to investigate potential fixed link connections, such as tunnels, along ferry routes on the Sound of Harris, the Sound of Barra, and between Mull and the Scottish mainland; further notes comments made by the then Cabinet Secretary for Net Zero, Energy and Transport, on 20 January 2022, that fixed links on these routes "could improve communities" access to goods and services and make those islands more attractive for people to live and work in and visit"; understands that tunnels to connect communities on the Shetland Islands were deemed out of scope of STPR2 by Transport Scotland; acknowledges the creation of Shetland's grassroots tunnel action groups, made up of community members advocating the potential advantages of tunnels to connect the isles, and notes that some of these groups are crowdfunding for technical surveys; understands that there is support among stakeholders for opportunities to explore the benefits of short subsea tunnels in Shetland, and notes the calls for a fixed link to replace the ferry on the Corran Narrows.

*S6M-11354 Fergus Ewing: Dualling of the A9 and A96—That the Parliament notes calls for the Scottish Government to bring forward an announcement, as soon as possible, in the form of a Ministerial Statement to the Parliament, containing full details of its plans to dual the A9 and the A96; further notes the belief that such a Ministerial Statement on the A9 dualling, which it stated would be provided in autumn 2023, should include a new timeline, setting out by when the dualling of the A9 between Perth and Inverness shall be completed in its entirety and full details of when each of the remaining sections to be dualled shall be dualled, in accordance with a published programme; notes the view that such a programme must ensure that work on the remaining nondualled sections is carried out continuously so that there is an uninterrupted flow of work progressing the project; further notes the view that the Ministerial Statement should include an announcement that the four sections with made orders, which, it understands, were published two years ago, will enter a formal procurement process, to ensure that there is a continuous flow of work on them, and swift progression of preparatory work on all of the other non-dualled sections; notes the belief that the statement should also include publication of the Reporter's recommendations from the Public Local Inquiry on the road from Killiecrankie to Glen Garry, which was held in January 2020, and of the Scottish Minister's decision on the Reporter's recommendations from April 2021 regarding the Dalraddy to Slochd section; further notes the view that the statement should confirm the establishment of an A9 Programme Board to oversee the

swift progression of the project, along with its remit, and that the board should be chaired by the Minister for Transport, or cabinet secretary with responsibility, should include the MSPs representing the parliamentary and regional constituencies which, within their boundaries, have sections of the A9 that have not yet been dualled, as well as senior elected representatives of Highland and Perth and Kinross councils; notes the calls for the Scottish Government to proceed immediately to issue the made orders in respect of the A96, which, it understands, were promised "in the coming weeks" during a parliamentary debate in November 2022, but have not yet been delivered; further notes the calls for the Scottish Government to announce the construction of the section of the road from Smithton, Inverness, to Auldearn, including the Nairn by-pass, with a timeline that sets out when that section of the A96 dualling shall be completed; notes the view that the work on sections of the A9, and the section of the A96 from Smithton to Auldearn, including the Nairn by-pass, can, and must, be carried out concurrently, and further notes the view that it is vital that this first section of the A96 enter the formal procurement process immediately, so that further delay is avoided.

*S6M-11431 Collette Stevenson: Celebrating 20 Years of Healthy and Active in East Kilbride—That the Parliament congratulates Healthy and Active in East Kilbride, which has been a key part of the town's community for 20 years; commends everyone involved in the organisation for all their great work in conjunction with partner organisations to promote health and wellbeing; understands that the charity has delivered an ever-increasing range of services within the community to help local people, regardless of their circumstances, including Shopmobility, Support at Home, exercise classes, and arts and crafts, as well as signposting and support for mental health; believes that the new Healthy and Active in East Kilbride electric minibus service, which offers wheelchair-accessible transport and affordable ticket costs, is a fantastic community asset, and applauds the friendly volunteer drivers who help connect the community to the Meeting Place Café; considers that the Café has been a brilliant community hub for more than a decade, offering a warm welcome and supportive space for everyone; understands that Healthy and Active in East Kilbride also offers outdoor programmes, events and activities to assist with the local mission to become more sustainable: further understands that the charity's transition to a community anchor organisation in 2020 enabled it to become a key voice within the East Kilbride Third Sector Locality Network; believes that all of these services are only possible with the amazing and dedicated team of staff, board members and volunteers, who it considers go above and beyond to ensure the continuing success of the services, and wishes Healthy and Active in East Kilbride all the best for the future.

*S6M-11395 Bill Kidd: Global Day of Action Against Nuclear Weapons—That the Parliament notes the Global Day of Action Against Nuclear Weapons taking place on 26 November 2023, aimed at calling for an end to nuclear weapons, alongside bringing attention to the United Nations Treaty on the Prohibition of Nuclear Weapons (TPNW); further notes that the Second Meeting of States Parties to the TPNW will take place the week of 27 November to 1 December 2023, in the Trusteeship Council at the United Nations Headquarters in New York; understands that the TPNW reached the required 50 state parties for its entry into force on 22 January 2021, when it became binding on the states that ratified it; welcomes the participation of members of Scotland's civic and political society who will attend as observers, despite what it sees as the UK Government's refusal

*S6M-11393 Rona Mackay: Impact of Conflict in Gaza and Israel on Pregnant Women, Babies and Children—That the Parliament expresses grave concern at the reported suffering of pregnant women and newborn babies in the war-torn regions of Gaza and Israel; notes that the Cross-Party Group (CPG) on Men's Violence Against Women and Children understands that around 4,000 pregnant women and their babies are unable to access basic prenatal and postnatal healthcare and support; further notes that the CPG supports the Parliament's call for an immediate ceasefire; is distressed at what it considers will be the inevitable loss of life on a tragic scale; expresses further extreme concern that the physical and mental impacts of this war and its associated trauma will, it believes, affect significant numbers of any surviving children for the rest of their lives; reflects with sadness that safe pregnancy, childbirth, infancy and childhood should be basic human rights, but that they can no longer be guaranteed in these war-torn areas; expresses deep gratitude to all individuals and agencies already engaging in the aid efforts and those working towards resolution in the most challenging of conditions; calls on the UK Government to do everything in its power to protect these precious lives and promote a swift and peaceful outcome to this conflict, and notes that the CPG has written to the UK Government and the British Medical Association (BMA) urging them to enable more medical supplies, and to support the engagement of more medics in this warzone urgently to alleviate what it sees as the inhumane suffering.

*S6M-11383 Kevin Stewart: Gambling Harm—That the Parliament expresses concern at recent reported figures from GambleAware, which show that nearly half of all gamblers between the ages of 18 and 24 have gambled more than they can afford to lose; is appalled at reports that 36% of young people have borrowed money or sold possessions to place a bet and that 39% said that they have experienced mental health problems related to their gambling; believes that gambling harm causes great grief for individuals and families; regrets that the proposed Gambling Reform Bill did not feature in the recent King's Speech, and calls on the UK Government to help reduce gambling harm by bringing forward the Gambling Reform Bill as soon as possible.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
