Members' Business motions that have achieved cross party support

***[S6M-10793](#) Maggie Chapman: Climate Justice and Support for a Global Loss and Damage Fund**—That the Parliament recognises what it sees as the severe impact that human-caused climate change is having on the planet; believes that communities across Scotland, including in the North East Scotland region, as well as globally, are already being negatively affected by the climate emergency; considers that, disproportionately, those most acutely affected by these impacts are those who have contributed the least to the climate crisis; believes that this is a fundamental and grave injustice, compounded by histories of colonialism and oppression; welcomes the decision at the 27th UN climate conference (COP27) to establish an international solidarity fund for climate-related loss and damage; recognises and welcomes that Scotland reportedly played a key role in breaking a 30-year logjam on loss and damage after COP26 in Glasgow; notes and welcomes the reported support of parliamentarians across the world for the loss and damage pledge, including supporters in the Scottish Parliament, and notes the calls on the UK Government, as a party to the 28th UN climate conference (COP28), to support the operationalisation of the fund, to ensure that the money attributed is new and additional to the climate finance commitments already made, and not taken from existing official development assistance budgets, and to commit to providing loss and damage finance in the form of grants, not loans.

Members' Business motions that have not achieved cross party support

***[S6M-10827](#) Paul O'Kane: Dying in the Margins**—That the Parliament welcomes the University of Glasgow and Marie Curie research project, *Dying in the Margins*, as well as *The Cost of Dying* photography exhibition taken from the project; understands that the project ran from 2019 to 2023, and was funded by the Economic and Social Research Council (ESRC) and UK Research and Innovation (UKRI); further understands that the project shed light on what it sees as the profound effect that people's socio-economic circumstances can have on their end of life experience; understands that, as part of the project, participants who were living with a terminal illness were photographed by Margaret Mitchell to create images conveying aspects of their end of life

experience, and were given a camera to document their end of life experience themselves; considers that the project highlights the important challenges that are faced by people with a terminal illness who are living with poverty, and what it sees as structural disadvantage, including, but not limited to, unsuitable housing, energy costs and lack of income support; commends the bravery of the project's participants, their families and carers, who documented their lives at, it considers, the most challenging time, to inform the public conversation around improving the end of life care for those living with poverty, including those in the West Scotland region, and what it sees as structural disadvantage; recognises the expertise of those who worked on the project, including University of Glasgow researchers, Dr Naomi Richards and Dr Sam Quinn, University of Auckland researcher, Professor Merryn Gott, and Marie Curie Head of Research and Innovation, Dr Emma Carduff; notes that the photography exhibition will be displayed in the Scottish Parliament on the week commencing 13 November 2023, and further notes the encouragement for MSPs to visit it and consider how they can tackle some of the issues that it raises.

***S6M-10823 Roz McCall: World Stroke Day 2023**—That the Parliament recognises World Stroke Day, which takes place on 29 October 2023; understands that Chest Heart & Stroke Scotland estimates that around 136,000 people in Scotland are living with the impact of a stroke; notes that stroke is a leading cause of adult disability in Scotland; commends the work undertaken by Chest Heart & Stroke Scotland to provide community healthcare support services, which enable stroke survivors to build confidence and manage their condition through supported self-management; considers that Chest Heart & Stroke Scotland's *One in Five* report demonstrates that too many stroke survivors in Scotland are unable to access rehab support, and notes the belief that enshrining the "right to rehab" as a human right in Scotland would give everyone who is living with the impact of a stroke access to the care that they need, when they need it, for as long as they need it.

***S6M-10801 Roz McCall: Basic Care Standards in Palliative Care**—That the Parliament notes the support for the provision of palliative care services in a place of the patient's choosing, wherever possible; understands that the vast majority of people who die each year in Scotland require palliative care services, including in the Mid Scotland and Fife region, where figures reportedly show that, of the 8,095 people who died in NHS board areas within the region in 2021-22, 7,285 had a palliative care need; recognises that, for a number of patients, despite a desire for at-home end of life care, clinical advice and practicality means that palliative care in a hospital setting is deemed more appropriate; notes with concern the recent reported decisions to permanently close some hospice wards, which, it believes, deliver vital and valued care to patients and their families from across Scotland; expresses regret at what it sees as the wide variation in the provision of palliative care across NHS boards in Scotland; considers reports of inadequate patient experiences at some NHS boards to be deeply concerning and notes the view that this reflects a need for such regional variations in the provision of palliative care to be addressed with the utmost urgency; acknowledges the reported pressures on NHS boards to deliver palliative care services without adequate specialist facilities such as hospice wards, and notes the view that the Scottish Government should investigate cases where basic care standards have not been met and ensure that the human rights of all patients are met without exception.

***[S6M-10788](#) Daniel Johnson: Increase in Youth Antisocial Behaviour**—That the Parliament acknowledges the reported concerning increase in youth antisocial behaviour, both in Scotland generally and locally in the Edinburgh Southern constituency; shares its concern with the reported experiences of local businesses in the Edinburgh Southern constituency and, in particular, local retail and entertainment venues around the New Market Road area, where, it understands, a supermarket chain's experience of antisocial behaviour is among the highest nationally; notes the reported impact that such an increase in youth antisocial behaviour is having on both the public's and retail workers' safety; praises the work done by the police to tackle this issue in light of the reported increasing workforce pressures that the force is facing, and notes the calls on the Scottish Government to do all that it can to address this issue. **R**

***[S6M-10832](#) Paul O'Kane: Congratulating Patrick Walker on Being Shortlisted in the Final of the UK Teacher of the Year Award 2023**—That the Parliament celebrates Patrick Walker for reaching the final of the UK Teacher of the Year Awards; understands that the awards ceremony will be held in London in November 2023; appreciates what it sees as the efforts that Patrick undertook to ensure that parents could support their children with their school work during the COVID-19 pandemic lockdown; congratulates him on his achievements so far; recognises and values the work that teachers across Scotland, including Glasgow, do to support young people to live up to their full potential; understands that Patrick teaches at Turnbull High School in Bishopbriggs, and wishes him the best of luck.

***[S6M-10831](#) John Mason: Undermining Local Authorities**—That the Parliament considers that introducing more powerful provosts, such as mayors in England, or similar, would be a major mistake and would undermine local authorities; further considers that such provosts or mayors would be a centralising move, taking power away from local authorities when, it believes, the focus should be on trying to decentralise more powers towards them; commends the existing structures, such as the regional transport partnerships and city regions, whereby local politicians of different political persuasions and representing different geographical areas can, it believes, work together for the good of their wider region; considers that, with a population of only around 5.4 million, Scotland does not need yet another layer of government; believes that some politicians in Scotland want to copy everything that England does, despite the fact that England is much larger and faces different challenges; considers that smaller countries like Scotland can benefit from simpler structures, and should need fewer public bodies and less bureaucracy, and hopes that the idea of what it sees as centralising provosts or mayors will not be taken seriously.

***[S6M-10830](#) Sharon Dowey: Ayr's Bronwyn Close Named Best in Scotland at the Volunteers for Museum Learning Awards**—That the Parliament congratulates Ayr's Bronwyn Close on being named best in Scotland at the Volunteers for Museum Learning Awards 2023; notes that the awards are run by the British Museum and the Marsh Charitable Trust, and aim to celebrate the important contribution that volunteers across the UK make to museums and their visitors; understands that Bronwyn holds a Master of Science (MSc) in Museum Education from the University of Glasgow, and has been volunteering with the Maritime Museum, in Irvine, for one year; recognises her contributions, which include using her MSc to develop the museum's under-fives weekly creative session and education programme; understands that Bronwyn helped develop learning boxes that take maritime heritage to the classrooms of local schools; applauds Bronwyn for all her hard work and contributions, and commends her for this fantastic achievement.

***[S6M-10829](#) Paul O'Kane: Save the Children's Better for Babies Report**—That the Parliament understands that families with a baby under one year old, which is one of the Scottish Government's six priority groups for reducing child poverty rates by 2030, have a significantly higher risk of experiencing poverty; recognises that, in the first 12 months, a baby's brain grows rapidly and they begin to develop the building blocks that, it understands, will determine their future health outcomes, educational outcomes and earning potential; understands that evidence shows that experiences of poverty in a child's first 12 months can impede this crucial development, more so than at any other time in their life, and lead to poorer outcomes throughout childhood and into adulthood; notes that, despite the harm that poverty can cause, over a third of families with a baby under one year old in Scotland are living in poverty; considers that there is a limited window in which to ensure that a baby gets the right start in life; believes that society must get it right for all babies, and agrees with new analysis from Save the Children, which, it understands, states that part of the solution is increased targeted investment in reducing child poverty rates in families with a baby.

***[S6M-10825](#) Kate Forbes: North Korean Refugees Fleeing Persecution**—That the Parliament notes with concern reports that China may have repatriated 600 North Korean refugees on 9 October 2023; understands that many of these refugees are Christians fleeing persecution, who were attempting to go to South Korea; further understands that the refugees are being taken to prison camps, with some even facing execution, and urges the UK Government to initiate dialogue with Chinese authorities to facilitate the deportation of the remaining North Korean refugees to other countries, rather than sending them back to North Korea and thereby, it believes, jeopardising their lives.

***[S6M-10822](#) Maggie Chapman: International Day for the Eradication of Poverty**—That the Parliament marks the United Nations International Day for the Eradication of Poverty, to be observed on 17 October 2023, which is an annual observance that aims to promote understanding and dialogue between people living in poverty and wider society; recognises what it sees as the importance of universal access to fair work and social protection as a means to uphold human dignity for all people, and considers that such work must empower people, provide fair wages and safe working conditions, and fundamentally recognise the inherent value and humanity of all workers; believes that well-funded social security programmes, such as the trailblazing Scottish Child Payment, are urgently needed across the UK to assist in providing income security for society's most vulnerable members, and further believes that strong global partnerships between governments, businesses, and civil society organisations, as seen through such actions as the Montrose Community Trust's Free Kicks initiative, which aims to address food insecurity in deprived areas of Montrose, as well as focussing on the overall health and wellbeing of those taking part, are vital to achieving equitable development and ensuring that no one is excluded or left behind.

***[S6M-10821](#) Maggie Chapman: International Day of Rural Women**—That the Parliament acknowledges the observance of the United Nations International Day of Rural Women on 15 October 2023, which is an annual observance that recognises the invaluable contribution of rural women to development; understands that women account for a substantial proportion of the agricultural workforce, including through their informal work, and perform the bulk of unpaid care and domestic work within families, households, and communities in rural areas; considers that women make significant contributions to agricultural production, food security and nutrition, land and natural resource management, and building climate resilience; believes that the Scottish Government's commitment of £300,000 per year until 2024-25 to support women in agriculture, by implementing the recommendations of the Women in Agriculture Taskforce, can assist in removing structural barriers that constrain women's decision-making power and political participation in rural households and communities, and further believes that women and girls in rural areas globally who lack equal access to productive resources and assets, public services, such as education and healthcare, and infrastructure, including water and sanitation, must be given the support that they need.

***[S6M-10820](#) Maggie Chapman: International Day for Disaster Risk Reduction**—That the Parliament acknowledges the United Nations International Day for Disaster Risk Reduction on 13 October 2023, which is an annual observance that takes place following the Midterm Review of the Sendai Framework for Disaster Risk Reduction 2015-2030, where the UN General Assembly, in May 2023, adopted a political declaration to accelerate action to strengthen disaster resilience; notes that this year's focus is to address the connection between disasters and inequality; considers that each adversity reinforces the other and that unequal access to services leaves the most vulnerable exposed to the danger of disasters, while the effects of disasters exacerbate

inequalities and push those most at risk further into poverty, as seen in climate emergency induced disasters from Libya to Pakistan in recent years; believes that all sections of society must take action to prevent and reduce losses in lives, livelihoods, economies and basic infrastructure for all communities, especially those most at risk; commends Aberdeenshire Council for the reported success of its Stonehaven Flood Protection Scheme in protecting Stonehaven from recent heavy rainfall, and urges all levels of government across Scotland and the wider UK to take similar proactive climate emergency mitigation efforts in response to the reported worsening effects of the climate disaster.

***S6M-10818 Kaukab Stewart: Congratulating Professor Craig Clark on Winning the Strathclyde Chancellor's Medal**—That the Parliament congratulates Professor Craig Clark, Professor of Practice for Space at the University of Strathclyde, on winning the Strathclyde Chancellor's Medal; recognises that the Chancellor's Medal was established in 2014 to mark the 50th anniversary of Strathclyde receiving its Royal Charter and is presented to individuals who have made an outstanding contribution to the University of Strathclyde, or to public life nationally and internationally, and who represent Strathclyde's values; understands that Professor Clark is a visionary space engineer and entrepreneur renowned for his pioneering work in commercialising small satellites; further understands that, in 2005, Professor Clark founded Clyde Space Ltd, Glasgow's first space company; understands that, in July 2014, Clyde Space launched UKube-1, Scotland's first satellite, and received the Queen's Award for Enterprise in 2017; acknowledges that Professor Clark was appointed a Member of the Order of the British Empire (MBE) in 2013, is a Fellow of the Royal Academy of Engineering, the Royal Aeronautical Society and the Institution of Engineers in Scotland, and that he has also been awarded an honorary doctorate from the University of Glasgow and is an inductee of the Scottish Engineering Hall of Fame, and commends Professor Clark for what it sees as his visionary work and for winning this award.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
