Members' Business motions that have achieved cross party support

*S6M-10526 Collette Stevenson: Challenge Poverty Week 2023—That the Parliament recognises Challenge Poverty Week 2023, which is coordinated by the Poverty Alliance, Scotland's anti-poverty network, and which runs from 2 to 8 October; notes that activities, events and actions will take place across Scotland to highlight the realities of, and solutions to, poverty, as well as increasing public support for tackling poverty; understands that the week emphasises the importance of a number of key policy asks, to help to unlock people from the grip of poverty, including the role of communities, access to food and adequate incomes; believes that over one million people in Scotland, including 250,000 children, are living in the grip of poverty and that the ongoing cost of living crisis continues to pull even more into hardship; notes the view that governments, politicians, civil society and communities all have a role to play in solving poverty; understands that particular groups of people, including low-paid women, lone parents, disabled people and people from black and minority ethnic backgrounds are disproportionately experiencing poverty; notes the view that poverty in Scotland can be solved by utilising all levers to boost incomes and reduce the impact of the cost of living crisis; further notes the view that people in Scotland support action to end poverty and believe in compassion and social justice; celebrates the work undertaken by organisations and communities across Scotland to stem what it sees as the rising tide of poverty, and notes the view that people across Scotland, including all MSPs, should attend and support events and activities in their areas to mark Challenge Poverty Week 2023.

<u>S6M-10491</u> Keith Brown: Devolution of Employment Law—That the Parliament considers that anti-trade union legislation, such as the Conduct of Employment Agencies and Employment Businesses (Amendment) Regulations 2022, and the Strikes (Minimum Service Levels) Act 2023, poses a significant risk to workers' rights, including in the Clackmannanshire and Dunblane constituency; believes that a progressive approach to industrial relations along with greater, not fewer, protections for workers is at the heart of a fairer and stronger economy; further believes that trade unions are key social partners in delivering economic and social aspiration, and that they are vital for ensuring that the voices of workers are heard; welcomes that the TUC has recently backed a motion calling for the devolution of employment law to Scotland and a repeal of all

current anti-trade union legislation; considers that devolution of employment law is supported by the majority of current MSPs; notes the calls on the UK Government not to further erode what it sees as the hard-won rights of workers; further notes its commitment to working in partnership to entrench and build on these rights, and notes the calls for employment law to be devolved to the Scottish Parliament immediately.

*S6M-10491.1 Daniel Johnson: Devolution of Employment Law—As an amendment to motion S6M-10491 in the name of Keith Brown (Devolution of Employment Law), leave out from "the devolution" to end and insert "the repeal of all anti-trade union laws and for new legislation to deliver stronger employment rights for workers; notes what it sees as the Scottish National Party administration's use of exploitative zero hours contracts, and acknowledges that the Labour Party has committed to banning all zero hours contracts, outlawing fire and rehire practices, giving rights to workers such as parental leave and sick pay from day one, and delivering a genuine living wage; agrees with the General Secretary of the TUC that the Labour Party's A New Deal for Working People amounts to the biggest expansion of workers' rights in decades, and considers that this would improve workers' rights across the whole of the UK, preventing good practice in some areas from being undercut; notes the belief that delivering this package should be the priority of any UK government, and welcomes the commitment from the Labour Party to introduce legislation on A New Deal for Working People within its first 100 days in office before looking at how those rights can be strengthened by devolution."

*S6M-10554 Marie McNair: Clydebank Barber Shop Wins Flurry of Awards—That the Parliament recognises Barber Barber in Clydebank for receiving numerous awards since it opened in January 2022; understands that the shop has a unique approach to providing hair and aesthetic services to gentlemen; believes that men need more opportunities to discuss their mental health and that Barber Barber encourages this, with access to video games and pool tables; applauds its achievements, as Best Barber Shop in Dunbartonshire in the Scottish Business Awards, Best Barber Shop of the Year in Scotland, and Spotlight Salon at the UK Hair and Beauty Awards, and celebrates innovative entrepreneurship in our communities.

*S6M-10553 Marie McNair: Celebrated Clydebank Poet Launches Ten Times Tam Collection of Works—That the Parliament congratulates Thomas Cox, from Dalmuir, on the recent launch of a collection of his poems; understands that the talented poet launched his collection of work titled *Ten Times Tam* in Dalmuir Library, alongside Clydebank Writers Group; extends thanks to West Dunbartonshire Libraries Services staff for hosting the event; acknowledges the heartfelt sentiment in each of Tam's poems; celebrates the creative passion of Scotland's bards, and wishes Thomas well in his future projects.

*S6M-10552 Marie McNair: Dalmuir Park Housing Association Sets Example in Advocacy for Vulnerable Residents—That the Parliament recognises the efforts of Dalmuir Park Housing

Association in advocating for vulnerable residents; understands that the housing association received a glowing report from the Housing Inspectorate after a recent evaluation; further understands that the report highlighted the compassion offered by staff, the access to a welfare rights advice surgery, advocacy support amongst other organisations and efforts to tackle social isolation, and encourages other housing associations to reflect on the work of Dalmuir Park Housing Association and strive to achieve what it sees as such positive impacts in their communities.

*S6M-10551 Alasdair Allan: The Passing of Ronnie MacKinnon—That the Parliament notes with sadness the passing of former Scotland international football player Ronnie MacKinnon; recalls Mr Mackinnon's role in the historic 3-2 victory at Wembley in 1967, in a career that saw him earn 28 Scotland caps; further recalls his successful club career over 12 years with Rangers FC, which saw him inducted into the club's Hall of Fame after making well over 400 appearances and winning the league, the Scottish Cup, the Scottish League Cup as well as a domestic treble; recognises his strong maternal links with Carloway in na h-Eileanan an Iar, to where he was evacuated in the Second World War and later holidayed; notes his role as ambassador for the Lewis and Harris Rangers Supporters Club, having settled in Point after retiring, and offers its sincere condolences to his wife, family and friends.

*S6M-10550 Alexander Stewart: Breast Cancer Awareness Month 2023—That the Parliament considers that 1 to 31 October is Breast Cancer Awareness Month 2023; understands that, approximately every 10 minutes, a woman is diagnosed with breast cancer in the UK; acknowledges that, especially during this month, many organisations, such as Breast Cancer Now, Breast Cancer UK, Macmillan Cancer Support and Marie Curie and Cancer Research UK, hold events and awareness days to raise funds and to highlight the importance of regular checks; understands that the advice is that, following self-checks, if anything unusual is discovered, even if no serious symptoms present themselves, a doctor should be visited; further understands that this can then involve a doctor carrying out a manual exam and thereafter arranging for a mammogram, which charities say is painless and only takes about 10 minutes; understands that slight pain can also be a sign of a benign cyst but that it is always better to be sure; considers that, in all cases, early detection is key and can be a life-saver, and notes the recommendations from many related organisations to make a mammogram appointment during Breast Cancer Awareness Month 2023, with the option of taking a friend or family member along for peace of mind.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
