*S6M-12834 Jim Fairlie: Automated Vehicles Bill - UK Legislation—That the Parliament agrees that the relevant provisions in Part 1, Chapter 6, clause 40, Part 2, Chapter 1, clauses 46 to 49 and 51, Part 5, clauses 82 to 85, 87 to 90 and Schedule 6 of the Automated Vehicles Bill, introduced in the House of Lords on 8 November 2023 and subsequently amended, so far as these matters fall within the legislative competence of the Scottish Parliament or alter the executive competence of the Scottish Ministers, should be considered by the UK Parliament.

Members' Business motions that have not achieved cross party support

*S6M-12841 Clare Haughey: Seventh Anniversary of the Two-child Benefit Cap—That the Parliament regrets to mark the seventh anniversary of the introduction by the UK Government of the two-child benefit cap, and the associated so-called rape clause; notes with alarm reports that over 87,000 children across Scotland are affected by the cap, including 3,610 in South Lanarkshire: further notes the work of the Joseph Rowntree Foundation, which reports that the poverty rate for children in families with three or more children was almost twice as high as the poverty rate for children in one- or two-child families in 2021-22, at 43% compared with 23% and 22% respectively, as a result of UK welfare policies such as the two-child benefit limit; highlights what it considers to be the contrast between the inhumane practices of the UK Government's Department for Work and Pensions and the compassionate approach of the Scottish Government's Social Security Scotland; understands that the Scottish Government has already spent more than £733 million over the last five financial years to mitigate UK Government welfare policies, despite what it sees as a remarkably challenging financial environment and the fiscal limitations of devolution; notes that the Scottish Child Payment and other devolved policies are forecast to keep up to 100,000 children in Scotland out of relative poverty in this financial year; further notes the view that Scotland should continue to build a social security system that is founded on dignity, fairness and respect, and notes the calls urging the UK Government to reverse the two-child benefit cap and what it regards as the other abhorrent and ineffective welfare reforms that have been implemented over more than a decade of austerity.

*S6M-12801 Michelle Thomson: Taliban's Suppression of Women's and Girls' Rights in Afghanistan—That the Parliament condemns what it sees as the continued suppression of the rights of women and girls in Afghanistan, following the takeover by the Taliban authorities; appreciates that, since the Taliban took over Afghanistan in 2021, the United Nations has continued to condemn the actions being enforced and highlight the Taliban's reported behaviour in breaking international law; considers that the requirement to be accompanied by a Mahram, a male chaperone, at all times beyond the home severely inhibits female participation in society; notes the reported restrictions on daily life for women and girls, including access to education, the use of gyms and parks, access to beauty services, bans on women working in various sectors of society, the compulsory wearing of hijabs and the reduction in available aid to women unless being delivered by women workers; notes what it sees as the detrimental impact that restrictions to all educational levels will have on women and girls, including on their acquisition of skills, knowledge and professional development opportunities; further notes what it sees as the detrimental impact that the ban on women and girls accessing outdoor social areas and beauty services will have, including the loss of jobs and the loss of women-only spaces; is appalled by the recently reported intention of the Taliban to re-impose the stoning to death of women; notes reports that the United Nations has declared that the Taliban has restricted the rights of women so gravely that it has made Afghanistan the "most repressive country" in the world; further notes that the overall societal impacts caused by the Taliban restrictions reportedly include increasing food scarcity and reliance on humanitarian aid; understands that population displacement caused by the restrictions has wider impacts, with countries including Scotland welcoming refugees through both humanitarian routes and informal routes; notes the role of the Scottish Government in providing £1 million per annum through the Humanitarian Emergency Fund to international humanitarian crises, including in Afghanistan; recognises the contributions of local groups across Scotland, including those in the Falkirk district, in supporting refugees who have resettled in Scotland to realise their potential, and further condemns the acts of the Taliban authorities in Afghanistan.

*S6M-12774 Pam Duncan-Glancy: Impact of Reductions to Education in Glasgow—That the Parliament is concerned about reported proposals from Glasgow City Council to remove 450 teaching posts over the next three years, to remove and/or replace the MCR Pathways Programme from all Glasgow secondary schools, and, it understands, to put at risk the Developing the Young Workforce (DYW) initiative in Glasgow; notes the belief that the MCR Pathways and DYW programmes are key to supporting disadvantaged pupils, including care experienced pupils; recognises what it considers to be the significant impact that these programmes have on securing a reportedly high rate of positive destinations for the young people that they support; notes with concern that teachers, support staff and trade unions have reportedly stated that teaching and support capacity is already stretched in Glasgow, and that these reductions will worsen the situation, could increase incidents of violence in schools, and will make addressing the needs of pupils with additional support needs much more difficult; understands that parent councils, teachers, pupils, and MCR volunteers have all highlighted what they consider to be the hugely detrimental impact that these reductions will have on young people's lives; recognises the concerns of these groups, and notes the belief that these proposals are inconsistent with the aims of policies such as The Promise and Getting It Right For Every Child (GIRFEC).

*S6M-12762 Evelyn Tweed: Fundraiser for Cystic Fibrosis Trust in Memory of Oliver **Steele—**That the Parliament congratulates Natasha Cuthbert and Sean Steele, of Deanston, on raising vital funds for the Cystic Fibrosis Trust in memory of their son, Oliver Steele, who sadly passed away from cystic fibrosis aged just 14 months old on 16 July 2023; praises Natasha and Sean for their fundraising efforts, following the heartbreak of losing their young son; understands that this began with over £1,000 being raised through online donations and a collection following Oliver's funeral and, more recently, a charity football match between Deanston and Aberfoyle at Deanston Community Centre on 30 March 2024, where they raised over £3,400 through a raffle, tombola, bake sale, bouncy castle, refreshments, barbeque and the football match; further understands that Oliver, who lived with his mum, Natasha, in Deanston, was born at Forth Valley Royal Hospital on 10 May 2022, and at just two days old was rushed to the Royal Hospital for Children in Glasgow for surgery on a blocked bowel, which unfortunately could not be repaired at the time so Oliver was given a stoma, and that it was later discovered that the bowel issue was due to Oliver having cystic fibrosis, which led to multiple trips to hospital and several surgeries; notes that Natasha and Sean are keen to raise awareness of cystic fibrosis, which is a hereditary disorder affecting the exocrine glands that causes the production of abnormally thick mucus, leading to the blockage of the pancreatic ducts, intestines and bronchi, often resulting in respiratory infection, and to raise vital funds for the Cystic Fibrosis Trust; further notes that NHS Scotland states the symptoms of cystic fibrosis, including recurring chest infections, wheezing, coughing, shortness of breath and damage to the airways (bronchiectasis), difficulty putting on weight and growing, yellowing of the skin and the whites of the eyes (jaundice), diarrhoea, constipation, or large, smelly poo, and a bowel obstruction in newborn babies (meconium ileus): understands that, in the UK, all newborn babies are screened for cystic fibrosis as part of the newborn blood spot test, or heel prick test, carried out shortly after they are born, and that, if the screening test suggests that a child may have cystic fibrosis, they will need a sweat test and a genetic test to confirm that they have the condition; notes that there is no cure for cystic fibrosis, but that a range of treatments can help to control the symptoms, prevent or reduce complications, and make the condition easier to live with; understands that people with cystic fibrosis may need to take different medicines to treat and prevent lung problems, and that physical activity and the use of airway clearance techniques may also be recommended to help clear mucus from the lungs, and wishes Natasha and Sean continued success with their fundraising efforts in memory of Oliver, who they describe as the "happiest, funniest and most beautiful little boy in the world".
