*S6M-18369 Kenneth Gibson: Recognising the Impact of Chronic Kidney Disease (CKD)—
That the Parliament recognises the impact of chronic kidney disease (CKD) on individuals and the NHS, with, it understands, thousands of people reliant on dialysis or living with a kidney transplant, and many more at risk of progression; understands that CKD is one of the most common and resource-intensive long-term conditions but considers that it lacks a specific policy focus; welcomes the Scottish Government's work on a long-term conditions strategy and notes the belief that the Scottish Government should include CKD as a dedicated strand, with actions on prevention, early diagnosis, equitable access to transplantation, and a home-first approach to dialysis care; notes the view that increasing support for home dialysis and improving organ donation rates would improve outcomes and reduce system pressures, and further notes the belief that the Scottish Government should work with people across Scotland, including in the Cunninghame North constituency, who are living with kidney disease, as well as clinicians, third sector organisations and industry, to deliver meaningful change.

*S6M-18398 Marie McNair: Bearsden Woman Receives PRIDE Award for Coastal Trek—That the Parliament congratulates Tracey Howe, from Bearsden, on her recent recognition by the PEUGOT Attitude PRIDE Awards Europe 2025 at a prestigious ceremony in London; understands that Tracey was honoured for her efforts to raise money for the Beatson Cancer Charity, Marie Curie, Brainstrust, Coppafeel! and Breast Cancer Now by walking around the coastline of mainland Britain in memory of her late wife, Angela White; further understands that this is the 30th anniversary of Attitude magazine, and that its PRIDE Awards shine a spotlight on LGBTQ+ communities and remarkable individuals, such as Tracey; celebrates Tracey's achievements, and wishes her well on the rest of her trek.

*S6M-18397 Clare Adamson: World Drowning Prevention Day 2025—That the Parliament marks World Drowning Prevention Day 2025, taking place on 25 July; recognises that this global awareness day, established through UN General Assembly Resolution A/RES/75/273 in April 2021, aims to draw attention to the devastating impact of drowning on families and communities while promoting life-saving measures to prevent such incidents; understands that more than 230,000 people lose their lives to drowning worldwide every year, and that drowning is among the top 10 causes of death for children and young people aged one to 24; further understands that in the UK there are, on average, around 400 accidental drowning fatalities each year, with many incidents occurring in open water such as rivers, lochs, and coastal areas; believes that the 2025 theme, "Your story can save a life – Drowning prevention through shared experiences", highlights the power of personal experiences in raising awareness and encouraging safer behaviour around water; further believes that improved education on water safety, including an understanding of the Water Safety Code and the "Float to Live" technique, can prevent many drowning incidents: welcomes the ongoing efforts of organisations such as Water Safety Scotland, created by the Royal Society for the Prevention of Accidents (RoSPA), Scottish Water, the Royal National Lifeboat Institution (RNLI), and the Royal Life Saving Society UK, in developing free water safety resources and delivering awareness programmes in schools and communities; commends these organisations, along with the Scottish Fire and Rescue Service and the Darcey Sunshine Foundation, for hosting the fourth annual Water Safety Open Day on 25 July 2025 at Loch Lomond, and encourages individuals and families across Scotland to attend, share their experiences, and learn vital water safety skills. R

S6M-18396 Kevin Stewart: Calling on the UK Government to Recognise the State of Palestine Immediately —That the Parliament welcomes the decision of the French government to recognise the State of Palestine, and calls on the UK Government to immediately follow suit. *S6M-18395 Maurice Golden: Recognising the Success of NHS Grampian Dietitians in Recycling and Environmental Leadership—That the Parliament congratulates the team of dietitians at Aberdeen Royal Infirmary on what it sees as their outstanding success in transforming recycling practices within NHS Grampian; welcomes the reported dramatic increase in recycling of oral nutritional supplements and enteral tube feeds in the critical care department, from 6% to over 80% in a single year, as part of the "Recycle Plastic, It's Fantastic" initiative; commends NHS Grampian for demonstrating that it is possible, within health care settings, to exceed the Scottish Government's 70% recycling target; welcomes the news that staff have expanded awareness to include other items, such as food containers, IV bags and soft plastics, and understands that this recycling model has spread to NHS England, and encourages all NHS boards to adopt and scale similar programmes and to embed them within NHS Scotland's net zero ambitions.

*S6M-18390 Sarah Boyack: Edinburgh International Festival, the First Charity and Arts Organisation to Receive Net Zero Pathway Verification—That the Parliament congratulates Edinburgh International Festival (EIF) on becoming the first charity and arts organisation to achieve the British Standards Institute's (BSI) Net Zero Pathway verification; recognises its operational progress, including 56% and 26% reductions in electricity and gas emissions at The Hub, a 42% reduction in general waste through sustainable concessions and 58% reduction in printed paper since 2023; believes that this is a major milestone in its commitment to genuine emissions reductions and its ambition to reach net zero by 2045; welcomes what it sees as EIF's leadership in embedding sustainability across its operations and artistic programme, from locally built productions and artist residencies to significant reductions in energy, waste, and travel emissions; acknowledges what it sees as its 77-year legacy of bringing together diverse cultures through world-class dance, opera, music and theatre, and appreciates its role in inspiring debate and collaboration on climate action for the benefit of people and planet.

*S6M-18389 Alexander Burnett: Neurological Alliance of Scotland's Report, "Today's Challenge, Tomorrow's Hope"—That the Parliament welcomes the Neurological Alliance of Scotland's report, *Today's Challenge, Tomorrow's Hope*, which presents the findings of the second national survey of people impacted by neurological conditions; understands that this work adds to its *Together for the 1 in 6* report, which was published in 2022, and which, it believes, was the first time that data had been independently published in Scotland; acknowledges that there are estimated to be one million people in Scotland with a neurological condition; believes that over half of adult respondents did not feel that health and social care services were meeting their needs, and that children also struggled with accessing support in the school system; notes that the new report highlights the importance of improving diagnosis, to enable people to access treatment and support earlier, and emphasises the need for more specialists and health professionals in neurology services; understands that the report highlighted the challenges facing carers and the difficulties of looking after someone with a chronic, unpredictable and sometimes life-threatening condition; commends the Neurological Alliance of Scotland for its work, and believes that more support is needed to improve the quality of life for people with neurological conditions.

*S6M-18388 Kenneth Gibson: The 80th Anniversary of Victory over Japan Day—That the Parliament recognises the 80th anniversary of Victory over Japan (VJ) Day, marking the end of the Second World War on 15 August 1945, when Japan announced its surrender to the Allied forces following the United States' atomic bombings of Hiroshima and Nagasaki, the Soviet invasion of Manchuria and years of intense fighting in Burma, China and the Pacific; acknowledges the profound relief and celebration felt across Scotland, the UK and the Commonwealth as six years of global conflict came to an end, while also recognising the deep sorrow and loss experienced by so many families who lost their loved ones, including many in captivity; notes that Scotland will commemorate this historic occasion on 15 August 2025 with a national two-minute silence at

midday, and encourages communities across the country to take part in local events and tributes; further notes that Legion Scotland will host a special event, Scotland's Salute to VJ Day Anniversary Concert, at the Scottish National War Memorial in Edinburgh Castle as the national commemorative event; remembers the sacrifice of the 34,000 Scottish service personnel and approximately 6,000 civilians who lost their lives during the Second World War, including those killed in air attacks on Clydeside, and pays tribute to all those who served, those who endured, and those who never returned.

*S6M-18387 Stephanie Callaghan: Recognising the Life and Service of Matron Agnes **McGearey—**That the Parliament proudly recognises the life and service of Matron Agnes McGearey, who was a remarkable Scots military nurse, born in Mossend in 1909; recognises in particular her heroic efforts in the Chindit expeditions during the Second World War; understands that her unwavering dedication and compassion were recognised with her appointment as a Member of the Order of the British Empire (MBE) in December 1943 "for gallant and distinguished services in Burma and on the eastern front of India", and that she was described as "a mother to them all" by Major General Derek Tulloch in recognition of her role in restoring the strength and spirit of soldiers returning from the Burmese jungle; notes that she personally nursed Major General Orde Wingate through typhoid, an act believed to have saved his life, and that he later requested her to serve as Matron of the 19th Casualty Clearing Station at Imphal, where it believes her exceptional leadership and tireless devotion helped save countless lives of those returning from the jungle under the harshest conditions; acknowledges the many accounts from the Chindit expeditions that mention Matron McGearey, describing her as a "vigorous yet deeply compassionate humanitarian", who remained by her patients' sides until the very end, often writing to bereaved families to offer comfort and solace, embodying the highest ideals of compassion and duty; celebrates her distinguished career, which also included her beginnings as a staff nurse in the Queen Alexandra's Imperial Military Nursing Service, her promotion to Acting Matron, service under the Queen Alexandra's Royal Army Nursing Corps, and receiving the award of the Associate of the Royal Red Cross Medal in July 1941; recognises her courage and service at Dunkirk, where she was among the last nurses to evacuate, as well as in Malta, Burma, India and Palestine during the Second World War, before continuing her service in the Korean War and later in Malaya; notes that she sadly fell ill with cancer; wholeheartedly commends Matron McGearey as an inspiration to nurses, to the armed services and to Scotland; considers that her legacy of compassion, courage and service deserves lasting recognition; recognises that 2025 marks the 80th anniversary of Victory over Japan Day, which marked the closure of the Second World War, and pays tribute to the courage and sacrifice of all who served and fought to secure peace for future generations.

*S6M-18383 Alexander Stewart: Ruby Henderson, Taekwondo Champion, Heading to Croatia—That the Parliament welcomes the news that a young martial artist from Sauchie will head to Croatia in October 2025 to compete for her country in the Taekwondo World Championships; understands that Ruby Henderson has been selected to represent Scotland after her success in bringing home two medals from the European Championships in Sarajevo, in Bosnia and Herzegovina, during 2024; further understands that Ruby is a black belt, two-time Scottish champion, and that, in the past four years since 2021, it is said that she has been taking the taekwondo world by storm; understands that the Lornshill Academy pupil trains daily at the Scottish Martial Arts Centre in Tullibody: further understands that, when representing Scotland at the European championships in Sarajevo, Ruby brought home a silver and bronze in individual events and was part of the first Scottish girls sparring team to reach the European level; believes that, to prepare for this competition, she had to go through qualifiers and did a 12-week training course; further believes that, despite her success, Ruby's journey is entirely self-funded, unlike many of the athletes she competes against from other European countries, and that she has relied on generous community support to make these international competitions, including her father setting up a GoFundMe page; commends Ruby for her outstanding achievements thus far; further commends the local and wider communities' generosity in funding her competitions, and wishes her all the very best in Croatia and in her future endeavours.

The tenant has accrued rent arrears under the tenancy in respect of one or more periods, and the cumulative amount of those rent arrears equates to, or exceeds, an amount that is the equivalent of 6 months' rent under the tenancy when proceedings for an order for possession are raised on the basis of these circumstances.",

(b) after Case 8 there were inserted—

"Case 8A

The landlord who is seeking possession of the let house—

- (a) is suffering financial hardship, and
- (b) intends to alleviate that hardship by occupying the let house as the landlord's only or principal home for at least 3 months.

In this Case, references to the landlord—

- (a) in a case where two or more persons jointly are the landlord under a tenancy, are to be read as referring to any one of them,
- (b) in a case where the landlord holds the landlord's interest as a trustee under a trust, are to be read as referring to a person who is a beneficiary under the trust.".

Unlawful eviction: notification and determination of damages, etc.

- 8 (1) The Housing (Scotland) Act 1988 applies in accordance with the modifications in sub-paragraphs (3) and (4).
 - (2) The modifications set out in this paragraph and paragraph 8 have no effect in relation to actions taken by (or on behalf of) a landlord before this paragraph comes into force which result in the landlord being liable for damages by virtue of section 36(3) of the Housing (Scotland) Act 1988 (damages for unlawful eviction).
 - (3) Section 36 (damages for unlawful eviction) has effect as if—
 - (a) in subsection (3), for "assessed on the basis set out in" there were substituted "determined in accordance with",

- (b) subsection (6B) were repealed,
- (c) after subsection (7) there were inserted—
- "(7A) Where the court makes an order awarding damages to a former residential occupier by virtue of subsection (3), the court must send a copy of the order to the Scottish Housing Regulator.
 - (7B) Where the First-tier Tribunal makes an order awarding damages to a former residential occupier by virtue of subsection (3), the First-tier Tribunal must send a copy of the order to—
 - (a) the chief constable of the Police Service of Scotland, and

 - (7C) For the purpose of subsection (7B), a person is registered as a landlord with a local authority if the person is entered in the register prepared and maintained by the local authority for the purpose of Part 8 of the Antisocial Behaviour etc. (Scotland) Act 2004."

"37 Determination of damages

- (1) For the purpose of section 36(3), the damages that the court or, as the case may be, the First-tier Tribunal may determine as payable are to be an amount which is—
 - (a) not less than 3 months' rent, and
 - (b) not more than 36 months' rent,

taking into account the manner of the unlawful eviction and the impact that it has had on the tenant.

- (2) But, the court or, as the case may be, the First-tier Tribunal may reduce the amount of damages that would otherwise be payable under subsection (1) to an amount lower than 3 months' rent if it considers it appropriate to do so having regard to all the circumstances of the case.
- (3) Where two or more persons jointly were the landlord, the court or, as the case may be, the First-tier Tribunal may determine that—
 - (a) damages are payable by all, some or only one of the former landlords,
 - (b) each former landlord must pay a specified amount of damages, but the cumulative total of each of the amounts must not exceed 36 months' rent, or
 - (c) the former landlords are jointly and severally liable in respect of the whole amount of damages payable.
- (4) In this section, "rent" means—
 - (a) the amount that was payable in rent under the tenancy immediately before it ended, or
 - (b) in a case where two or more persons jointly were the tenant under the tenancy immediately before it ended, the amount mentioned in paragraph (a) divided by the number of persons who were at that time joint tenants under the tenancy.".
