Motions for Debate

***[S6M-17981](#) Murdo Fraser: Recognising the Economic Contribution of Scotland's Defence Sector**—That the Parliament recognises the significance of the defence industry to Scotland's economy, in providing secure, well-paid and highly skilled jobs and in driving innovation in the science, technology, engineering and maths (STEM) sector; notes that proposed increased spending on defence provides a substantial opportunity for growth; regrets that Scottish Government policy has meant that a Scottish Enterprise grant to support the Rolls-Royce specialist naval welding skills centre in Glasgow for submarine construction has been refused, and calls on the Scottish Government to drop the policy, which prevents public funds being invested in projects such as this.
