**\*[S6M-18169](#) Paul McLennan: Tantallon House Shortlisted for Awards**—That the Parliament congratulates Tantallon House in North Berwick, operated by Morar Living, on being shortlisted for two major national care industry awards; understands that the care home has received nominations in the Stars of Social Care Awards 2025 and the Dementia Care Awards 2025 for its outstanding contributions to residential care and dementia support; commends Crystal Soriano, who has been named a finalist in the Inspirational Care Home Manager (North and Midlands) category at the Stars of Social Care Awards; recognises Tantallon House's further shortlisting in the Dementia Care Employer category, which celebrates organisations that prioritise staff development and compassionate workplace culture; echoes the comments of Eric O'Hare, operations manager at Morar Living, who praised the dedication of staff and the commitment to creating homes where residents feel truly valued, and wishes the entire team at Tantallon House continued success and recognition for their vital work in the care sector in East Lothian.

**\*[S6M-18164](#) Jeremy Balfour: Concerns Over Disability Equality Plan Lacking Accountability and Targeted Actions**—That the Parliament is disappointed to read the recent publication of the Scottish Government's revised Disability Equality Plan, published on 20 June 2025; understands that this plan was supposed to outline realistic, accountable targets on how to improve the lives of the approximately one million disabled people in Scotland; understands that, at a meeting held on 13 November 2024 between various cross-party MSPs, disabled people's organisations (DPOs) and the Minister for Equalities, the DPOs strongly expressed their disappointment with the first draft of the plan; considers that the revised plan issued in June still contains no key dates for accountability, even though the minister responded to written question S6W-38899 stating that “the plan introduces a robust governance framework to hold us accountable for delivering on our commitments—whether that’s reducing the disability employment gap, reforming social care, or promoting and protecting disability rights”, and calls on the Scottish Government to stop hiding behind what it sees as false rhetoric, and to actually deliver a Disability Equality Plan that will start to break down barriers and meet some of the key requirements of disabled people in Scotland to allow them to participate fully and equally in society.

**\*[S6M-18163](#) Annabelle Ewing: Cowdenbeath Banking Hub**—That the Parliament welcomes the opening of a new banking hub in Cowdenbeath; notes that the hub will provide a range of traditional bank counter services, including cash withdrawals and deposits, cheque deposits and utility bill payments; further notes that the hub will support community banker services from Barclays, TSB and Royal Bank of Scotland; understands that the hub is currently situated on a temporary basis within the 99 Market Place store, 315-317 High St, Cowdenbeath, before eventually moving to a permanent home in the former TSB building at 92 High Street, Cowdenbeath, and recognises what it considers to be the importance of such a facility to those within communities who, it understands, for a variety of reasons, have been excluded and isolated by the shift towards electronic banking and what it sees as the disappearance of local branch banking services.

**\*[S6M-18159](#) Pam Gosal: Kilbowie Primary School Receives UNICEF UK Silver Award**—That the Parliament congratulates Kilbowie Primary School in Clydebank on being awarded the UNICEF UK Silver Rights Respecting School Award; notes that this prestigious award recognises the school's commitment to placing the United Nations Convention on the Rights of the Child (UNCRC) at the heart of its planning, policies and daily practices; acknowledges the school's achievements in promoting wellbeing, participation, positive relationships and self-esteem among pupils; acknowledges the dedication of the teachers, support staff, parents and carers in fostering an environment that respects and upholds children's rights, and wishes Kilbowie Primary School continued success in its efforts to support and empower young people.

encouraging the artistic development of young people; acknowledges the vision and leadership of Buchanan Galleries and the centre director, Kathy Murdoch, in creating this innovative space, which not only enriches Glasgow's cultural landscape but also strengthens the city's reputation as a vibrant hub for arts and entertainment; understands that the "Busk Stop" will operate on a rotation schedule, ensuring a diverse and fresh range of performances that contribute to the enjoyment of visitors and shoppers alike; recognises the importance of providing accessible platforms for young and emerging artists to showcase their talents, develop their skills and inspire others, and welcomes the commitment to supporting Scotland's next generation of creative talent, which is vital for the continued growth and success of the country's arts sector.

**[\\*S6M-18150](#) Liam McArthur: Shapinsay Community School Pupil Wins Gold Award at Scottish Mathematical Challenge 2025**—That the Parliament congratulates Wim Moore, a P7 pupil at Shapinsay Community School, on winning a gold award in the Scottish Mathematical Challenge 2025, which was run by the University of Aberdeen; understands that, in order to win this award, Wim had to individually finish a set of maths problems and had to clarify his workings for each problem; further understands that Wim had to travel down to Aberdeen to collect his gold award; commends Wim for all of his hard work in winning this outstanding award; wishes Wim every success in his future as a budding mathematician, and encourages more pupils across the country to take up the Scottish Mathematical Challenge in the future.

**[\\*S6M-18147](#) Paul Sweeney: Official Opening of the Janet Harvey Hall at Govan Shipyard Heralds a Bright New Future for Shipbuilding on the Upper Clyde**—That the Parliament welcomes the official opening of the Janet Harvey Hall at BAE Systems' Govan Shipyard on the River Clyde in Glasgow; recognises that the hall has been named in honour of Janet Harvey, who, in 1940, became one of the first female electricians to work on the Clyde when she joined Fairfield Shipbuilding and Engineering Co Ltd at just 18 years old, and who passed away on Armistice Day 2023 at the age of 101; acknowledges Janet Harvey's pioneering role in a male-dominated wartime workforce and, by extension, the courage and skill of the many women who stepped into critical industrial roles during the Second World War; notes that two of Ms Harvey's nieces, June Cofflet and Lynne Vernall, served as guests of honour at the opening ceremony and, alongside the Rt Hon Lord Provost of Glasgow and Jennifer Blee, naval ships manufacturing and facilities director, ceremonially cut the ribbon across the hall's massive "gigadoor"; further notes that the "gigadoor" is the largest of its kind in the world, with a surface area of 2,160 square metres, which, it understands, is large enough to accommodate six IMAX cinema screens; understands that the Janet Harvey Hall forms the centrepiece of a £300 million programme of modernisation and digitalisation across BAE Systems' Govan and Scotstoun shipyards; highlights that the hall

measures 170 metres in length, 80 metres in width and approximately 49 metres in height, making it one of the largest enclosed volumes in Scotland, and that it features a column-free internal space achieved through 80-metre-long steel trusses supported by lattice columns; understands that an estimated 195,000 cubic metres of material was used to infill the shipyard's former wet basin to form the foundations for the hall, using silt dredged from the riverbed; further understands that its construction utilised over 6,000 tonnes of steel and 20,000 cubic metres of concrete; notes that the facility is equipped with two 100-tonne Goliath cranes and two auxiliary 20-tonne overhead cranes, supplied by Konecranes; understands that it can accommodate up to 500 workers per shift, and that, with 13,000 square metres of floor space, it enables the simultaneous construction of two ships side by side under cover for the first time in the shipyard's 161-year history, a capability which it believes is of particular significance in Glasgow, known as the rainiest city in the United Kingdom, with an average of 170 rainy days per year; notes that the delivery of the hall was led by BAE Systems as the main client, with support from Turner & Townsend as project manager, Arch Henderson as civil engineers, Corstorphine & Wright and HLM as architects, McLaughlin & Harvey as the main construction contractor, Robert Bird Group as structural engineers, Severfield as the steelwork contractor, and Kane Group as the mechanical and electrical contractor, and understands that the facility is expected to sustain approximately 1,700 jobs in Scotland and a further 2,300 across the UK supply chain, improve schedule performance, reduce delivery intervals between ships, enhance quality through controlled-environment assembly, and contribute directly to the delivery of eight Type 26 frigates for the Royal Navy and future shipbuilding programmes, thereby supporting the UK's sovereign defence capability. **R**
