*S6M-18595 Pam Duncan-Glancy: World Arthritis Day 2025—That the Parliament notes that World Arthritis Day will be marked on 12 October 2025; understands that the day aims to raises global awareness of the existence and impact of rheumatic and musculoskeletal (MSK) diseases; believes that arthritis and MSK conditions affect one in three people in Scotland; considers that MSK conditions are a significant burden on NHS Scotland, with, it understands, orthopaedics currently accounting for one third of waiting times; further considers that there is a clear link between MSK conditions and economic deprivation and believes that these conditions are second only behind mental health in relation to claims for sickness benefit; notes the view that it vital that MSK conditions are prioritised to reflect the serious impact that they are having on Scotland's public health, economy and society, and applauds what it sees as the excellent work of Versus Arthritis in Scotland to raise awareness of arthritis and change lives through world-class research, campaigning and service delivery.

*S6M-18624 Paul Sweeney: Dying in Poverty at the End of Life in Scotland 2025—That the Parliament welcomes the publication of the Marie Curie report, *Dying in Poverty in Scotland 2025*; understands that the report is based on research carried out by Marie Curie and Loughborough University; notes that it found that end of life poverty in Scotland remains unchanged since 2024; understands from the research that one in four working age people and one in six older people still die in end of life poverty; considers that terminal illness exacerbates existing inequality and deepens the inverse care law where people in the most need of support are least likely to receive it; notes the report's findings that symptoms of terminal illness and diagnosis can result in higher energy and housing costs; believes that a terminal diagnosis can force both a dying person and their carers to reduce their working hours or give up paid work entirely; notes the view that more

must be done to target support to people at the end of life and their carers, and further notes the calls for the Scottish Government to take action to prevent people, including those in the Glasgow region, from dying in end of life poverty.

*S6M-18614 Bill Kidd: Nuclear Incidents—That the Parliament notes reports of the disclosure of a number of safety incidents at His Majesty's Naval Base Clyde (Faslane) and the Royal Naval Armaments Depot Coulport, including the second Category A incident in two years; further notes that the UK Government and Ministry of Defence documentation has confirmed a number of "nearmiss" incidents and safety breaches, including the radioactive contamination of Loch Long; notes what it sees as the concerns of constituents in Glasgow Anniesland and people across Scotland, and recognises the importance of ensuring the highest safety standards at these sites, particularly given their proximity to communities in Argyll and Bute and the wider west of Scotland.
