**\*[S6M-20447](#) Fulton MacGregor: Awareness and Support for People Affected by PANS and PANDAS in Scotland**—That the Parliament recognises that Paediatric Acute-onset Neuropsychiatric Syndrome (PANS) and Paediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections (PANDAS) are rare, but potentially severe, conditions that can result in the sudden onset of significant neuropsychiatric symptoms, including obsessive compulsive disorder, anxiety, tics and behavioural change; acknowledges the considerable impact that these conditions can have on children, young people, adults and their families; notes concerns about the limited awareness and understanding of PANS and PANDAS across health, education and social care in Scotland; recognises the establishment and work of PANS+ Scotland in supporting affected families and raising awareness of them, and notes calls for the Scottish Government, NHS Scotland and all other relevant public bodies to engage with PANS+ Scotland and other stakeholders to improve awareness, understanding and support for those affected by PANS and PANDAS in Coatbridge and Chryston and across Scotland.

**\*[S6M-20434](#) Kenneth Gibson: Towards the Fourth Anniversary of Russia's Full-scale Invasion of Ukraine**—That the Parliament recognises that 24 February 2026 marks the fourth anniversary of Russia's full-scale invasion of Ukraine following the illegal annexation of Crimea in 2014 and proxy war in Donetsk and Luhansk; believes that Russian forces continue to indiscriminately bombard Ukrainian cities and control around one fifth of Ukraine's territory, including Luhansk, Crimea and most of Donetsk, Kherson and Zaporizhzhia; considers that fighting and air strikes have resulted in over 53,000 civilian casualties and that President Putin's veiled threats throughout the war to use nuclear weapons have raised fears of escalation; notes that around 3.7 million people are internally displaced in Ukraine and roughly 6.9 million refugees are recorded globally, including over 29,000 Ukrainians who arrived in Scotland, including in Cunninghame North, with a sponsor in Scotland through the Homes for Ukraine scheme; acknowledges the immense military casualties suffered by both sides, particularly Russia, given what it sees as its profligate use of manpower; notes the view that any ceasefire or settlement that cedes territory or lacks binding security guarantees could allow Russia to regroup and renew attacks, and that this would create the risk of a Carthaginian peace intended to permanently weaken and then annexe Ukraine; further notes the view that robust international

    - (i) the management of deer found in Scotland’s lowland areas (as defined in the plan),
    - (ii) current and emerging deer management concerns, including any species specific concerns,
    - (iii) the venison industry, key venison facilities and venison supply chains,
    - (iv) identifying financial support for deer management, including how it can be most efficiently used,
  - (c) data which the Scottish Ministers consider relevant to the management of deer, including deer and urban deer population information, and national spread information,
  - (d) any other matter relating to deer management or promotion of venison that the Scottish Ministers consider appropriate.
- (3) The Scottish Ministers must review and update the plan—
  - (a) before the end of the period of 10 years beginning with the date on which the first plan was published under subsection (5), and
  - (b) before the end of each subsequent period of 10 years.
- (4) When preparing a plan under subsection (1), or reviewing and updating a plan under subsection (3), the Scottish Ministers must consult—
  - (a) SNH,
  - (b) such persons as they consider represent the interests of—
    - (i) persons undertaking deer management, and
    - (ii) the venison industry, and
  - (c) such other persons as they consider appropriate.
- (5) The Scottish Ministers must, as soon as reasonably practicable after preparing a plan under subsection (1), or reviewing and updating a plan under subsection (3)—
  - (a) lay the plan before the Scottish Parliament, and
  - (b) publish the plan.

- (6) In this section, “venison” means any part of the carcase of a deer which is edible by humans.
- (7) The Scottish Ministers may by regulations modify subsection (2) to add, adjust or remove information that must be included in a plan.
- (8) Regulations under subsection (7) are subject to the affirmative procedure.”.>

#### **60A Report on penalties in sea fisheries legislation**

- (1) The Scottish Ministers must publish a report on the effectiveness of relevant penalties in ensuring compliance with the sea fisheries legislation—
  - (a) within the Scottish enforcement area, and
  - (b) by Scottish fishing boats (wherever they are operating).
- (2) The report must, in particular—
  - (a) set out the relevant penalties covered by the report,
  - (b) explain why those penalties have been selected,
  - (c) assess the effectiveness of those penalties in ensuring compliance with the sea fisheries legislation, and
  - (d) identify any changes to the penalties that the Scottish Ministers consider likely to improve compliance with the sea fisheries legislation.
- (3) The report may include any other matters related to the sea fisheries legislation that the Scottish Ministers consider appropriate.
- (4) In preparing the report, the Scottish Ministers must consult such persons as they consider appropriate
- (5) The Scottish Ministers must—
  - (a) publish the report within the period of 2 years beginning with the day on which this section comes into force, and
  - (b) before publishing the report, lay the report before the Scottish Parliament.
- (6) The Scottish Ministers may by regulations modify a penalty in the sea fisheries legislation in connection with a change identified under subsection (2)(d).
