REQUEST FOR INFORMATION: 2022-670767

We acknowledge your request for information seeking:

Please can you provide a list of the current investments of the Scottish Parliament pension fund, including the value of each individual asset, correct as of the most recent quarter.

I would like this as electronic copies sent to this email address.

Your request was received on 21 January 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

The Fund Trustees appointed Baillie Gifford as an independent fund manager to invest pension contributions from the Scottish Parliamentary Pension Scheme (SPPS) and have delegated the responsibility for day-to-day investment management to them. Baillie Gifford invests the pension contributions in 3 pooled funds: Managed Pension fund, Diversified Growth fund and a new, more sustainable, Global Stewardship fund. Under this arrangement the SPPS is one of a number of investors in these pooled funds. It does not own any stocks, nor can the Fund Trustees determine the holdings within the pooled funds.

The Fund Trustees agreed in March 2021 that all future pension contributions would be invested in Baillie Gifford's Global Stewardship fund which invests in sustainable growth companies. It mitigates ESG risks by applying 'sin sector' exclusions, and then seeks to identify ESG opportunities by focusing on companies which Baillie Gifford's research suggests are a net benefit to society,

which balance the interests of all stakeholders, and which exhibit a responsible culture. In terms of "sin sector" exclusions the Global Stewardship fund formally excludes companies using the following ethical screen:

excludes companies that derive more than 10% of their annual revenue from alcohol, fossil fuels, tobacco, adult entertainment, armaments and gambling.

Furthermore, the Trustees agreed to divest 10% of its existing funds in the Managed Pension fund and switched that investment to the sustainable Global Stewardship fund.

Please find attached 3 reports from Baillie Gifford in PDF form listing the SPPS Holdings. The information covers the most recent quarter from 1 October 2021 to 31 December 2021.
