"In 2017 during an SNP Party Conference, First Minister Nicola Sturgeon stated that before the end of the year (2117) a "Not For Profit Energy Company" will be set up for Scotland. (or words to that effect)

Please identify the following as best you can:

- 1. Were you tasked with any work to carry out this statement by the First Minister?
- 2. What has been the progress of any work on Setting Up a Not For Profit Energy Co to date?
- 3. Has any application been made to Companies House & HMRC regarding set up of the above?
- 4. Since it appears this may be a Reserved Power, has OFGEN been contacted regarding the issue?
- 5. Was a Licence requested from OFGEN and what was the outcome?
- 6. If any/all works has been ceased, when were you instructed to do so?"

Your request was received on 20 January 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

This request relates to work carried out by Nicola Sturgeon in her capacity as First Minister and Head of the Scottish Government. The information requested is therefore not held by the Scottish Parliament and we cannot provide it to you. You may wish to contact the Scottish Government about this request.
