REQUEST FOR INFORMATION: 2022-671521

We acknowledge your request for the following information:

-A breakdown of all foreign dignitaries hosted at the Scottish Parliament from 2016 to 2022.

-The cost of hosting each individual foreign dignitary between 2016-22.

-The process by which foreign dignitaries are selected and are invited to visit the Scottish Parliament.

Your request was received on 8 February 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

Responding to each part of your request in turn, the position is as follows:

-A breakdown of all foreign dignitaries hosted at the Scottish Parliament from 2016 to 2022.

It is not possible to provide a complete list of all foreign dignitaries during this period. For example, the Parliament would not hold information on such dignitaries who have visited to meet with individual MSPs, or Cross-Party Groups. However, a list of the international delegations which have visited, where that visit was arranged through the Parliament's International Relations Office, is available on the Parliament's website.

-The cost of hosting each individual foreign dignitary between 2016-22.

The costs relating to the 'hosting' of visiting international delegations by the International Relations Office on behalf of the Parliament relate mainly to hospitality (tea, coffee, lunch, dinner). There are also some costs relating to the provision of transport. The Parliament does not pay the travel or accommodation costs of visiting delegations. The cost for each financial year is set out below:

There were no visits from international delegations in 2020-21.

-The process by which foreign dignitaries are selected and are invited to visit the Scottish Parliament.

The Parliament does not 'select' nor 'invite' foreign dignitaries to visit. Rather, it responds to requests from other parliaments, governments, international organisations, embassies, consulates etc for a delegation eg parliament Speaker, Ambassador etc to visit the Scottish Parliament. Such requests may be for a meeting with the Presiding Officer, or a Parliament committee etc to discuss areas of shared interest such as policy matters, or procedural (how parliaments work). Or, in the case of an Ambassador or Consul, as a courtesy when they are on an official visit to Edinburgh.
