REQUEST FOR INFORMATION: 2022-671804

We acknowledge your request for the following information:

In a previous FOISA request I was advised that the procurement activities of the Scottish Parliamentary Pension Scheme (SPPS) do not require to comply with the common requirements of public procurement. In follow-up to this:

- please could I have a plain English explanation of the reason why SPPS is not a contracting authority
- please could I have an explanation of how SPCB is not, or if it is, how SPPS is not (a contracting authority)
- confirmation that not being a contracting authority provides exemption from procurement regulations
- copies of the procurement policies and handbooks for SPCB and, if different, SPPS
- a breakdown of spend by supplier for SPPS for each of the years from 2010 to present with dates contracts for signed and the contractual periods

Your request was received on 14 February 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

Responding to each part of your request in turn, the position is as follows:

- please could I have a plain English explanation of the reason why SPPS is not a contracting authority

The Scottish Parliamentary Pension Fund vests in and is administered by the Fund trustees who are made up of current and pensioner members of the pension scheme, and who are appointed in accordance with the rules set out in the Schedule to the Scottish Parliamentary Pensions Act 2009. The Fund is

a contributory fund, financed by MSP contributions. The SPCB also contributes a percentage to the Fund as advised by the Government Actuary.

The Regulations provide that other bodies, who are governed by public law, will also be covered by the Regulations.

The Regulations define a "body governed by public law" as a body that has legal personality, is established for the specific purpose of meeting needs in the general interest, not having an industrial or commercial character and which—

- (a) is financed for the most part by the State, regional or local authorities, or by any other body governed by public law;
- (b) is subject to management supervision by any such authority or body; or
- has an administrative, managerial or supervisory board more than half the members of which were appointed by anybody referred to in sub-paragraph (a)".

We considered that the Fund trustees do not fulfil those criteria. The trustees do not have legal personality and the Fund was not "established to meet needs in the general public interest". It is not therefore necessary to consider the secondary criteria, but the trustees receive no remuneration for their role, and the Fund is contributory, with a small contribution from the SPCB, nor are the trustees subject to the control of the SPCB. Representatives of the SPCB may attend trustee meetings by invitation only. Lastly, the trustees are appointed by the Parliament on a motion of the SPCB, acting on the recommendation of the political parties.

- please could I have an explanation of how SPCB is not, or if it is, how SPPS is not (a contracting authority)
- confirmation that not being a contracting authority provides exemption from procurement regulations

Responding to parts 2 and 3 together, the SPCB is specified as a contracting authority under the heading of "central government authority" in Schedule 1 to the Regs, for the purposes of the Public Contracts (Scotland) Regulations 2015. It must conduct its procurements in accordance with the Regulations.

The activities of the trustees are not covered by the Regulations.

As this information is publicly available on the Scottish Parliament website we have provided a section 25 notice in terms of the technical requirements under FOI(S)A.

The SPCB does not hold procurement policies or handbooks for SPPS.

In line with the technical requirements of FOI(S)A we have provided a notice advising that the information you have requested in relation to the procurement handbook and procurement policies or handbooks for the SPPS is not held by the Scottish Parliament.

a breakdown of spend by supplier for SPPS for each of the years from 2010 to present with dates contracts for signed and the contractual periods

Please find attached a spreadsheet setting out the charges through the SPPS accounts for spend by supplier.

For each of the suppliers the position is as follows:

Auditors (BDO/PKF) – The contract with PKF ran from 2009 to 2013 based on a one year rolling basis, and the current contract with BDO started in 2013 (PKF merged with BDO in 2013). Extensions to the contract are made on an annual basis at the sole discretion of the Trustees.

Government Actuaries (GAD) – Contract awarded in 2011, continues until terminated by either party with 3 months' notice.

SPPA – Four-year contract from 1 April 2013 to 31 March 2017. Five-year contract from 1 April 2017 to 31 March 2023 with option to extend by 24 months by agreement with both parties.

Insurance (Aegon Scottish Equitable) – This was an insurance policy to pay the cost of any death in service lump payable under the pension scheme. The trustees decided to self-insure so let the policy lapse after 2010/11.
