REQUEST FOR INFORMATION: 2022-674560

We acknowledge your request for the following information:

I'm trying to get a better idea of the internet policies inside the parliament.

Can you release any policy document or guidance?

Are there different policies or protocols for members' access, their staff access and parliament staff access? If so could details of the difference be released?

Is there a list of sites or types of sites that are blocked by the parliament? Can you release this if so?

Can you share details of all attempts to access sites that have been blocked? Can you share the URL? Can you share who tried to access and how they tried to access? Ie were they a member's staff and did they try to use the WiFi?

Your request was received on 28 April 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

In response to the first part of your request about internet policies, there is no specific policy aimed at Members and their staff. <u>The IT Acceptable Use</u> <u>Policy</u>, applies to staff working for the Scottish Parliamentary Corporate Body (SPCB), staff on secondment and contractors who are authorised to use the SPCB's IT systems. We also have a <u>Social Media Policy</u> for all SPCB staff, staff on secondment and contractors who are authorised to use the SPCB's and the secondment and contractors who are authorised to use the SPCB's internet, e-mail and other business communications systems. Both these policies are published in the <u>Employee Handbook</u>.

Additionally, MSPs have a duty to act in accordance with the Code of Conduct for Members of the Scottish Parliament which sets out standards of conduct for Members in relation to their Parliamentary duties as an MSP. For information, the Code of Conduct can be accessed here: <u>Code of Conduct</u> <u>Scottish Parliament Website</u>

As this information is publicly available on the Scottish Parliament website we have attached a notice under section 25 of FOI(S)A in respect of information which is otherwise accessible.

We have interpreted the second part of your request as relating to websites which are blocked by the Scottish Parliament having regard to the nature and content of the website as opposed to websites which are automatically blocked externally on behalf of the National Cyber Security Centre (NCSC) drawing information from commercial threat intelligence feeds and the NCSC's own intelligence sources. If we have misunderstood the request, then please let us know.

The Scottish Parliament does not hold information on 'sites that are blocked by the parliament' as we do not actively prohibit access to websites (other than in the context of cyber security outlined above), therefore the information requested is not held by us and cannot be provided to you.

In line with the technical requirements of FOI(S)A we have provided a notice advising that the information you have requested is not held by the Scottish Parliament.
