REQUEST FOR INFORMATION: 2022-675460

We acknowledge your request for information seeking:

Please confirm the date when the public galleries in the Parliament were reopened to the public following restrictions put in place due to the Covid pandemic.

Please confirm whether any social distancing measures were in place when the public galleries re-opened and whether any social distancing measures remain in place today.

If social distancing measures remain in place at the present time, please indicate the basis on which such measures remain in place (e.g. public health advice, advocacy by trade unions or other reasons) and what objective criteria have been put in place which set out the conditions under which the measures would be lifted.

Your request was received on 20 May 2022 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

Responding to each part of your request in turn, the position is as follows:

Please confirm the date when the public galleries in the Parliament were re-opened to the public following restrictions put in place due to the Covid pandemic.

The Chamber public gallery re-opened to members of the public from 21 March 2022. The public galleries in the Committee rooms re-opened from 19 April 2022.

Please confirm whether any social distancing measures were in place when the public galleries re-opened and whether any social distancing measures remain in place today.

When the public galleries re-opened no social distancing measures were in place. However, staff recognised some visitors may wish to request additional space under the Distance Aware badge scheme. We therefore ensured requests like this could be accommodated if asked for. Additionally, we have always ensured any visitor with additional support requirements could request additional space if it was needed.

If social distancing measures remain in place at the present time, please indicate the basis on which such measures remain in place (e.g. public health advice, advocacy by trade unions or other reasons) and what objective criteria have been put in place which set out the conditions under which the measures would be lifted.

No social distancing measures remain in place at the present time. The decision to remove social distancing measures was made following Scottish Government advice under its new strategic framework, with the COVID threat level reducing to "low" on 21st March 2022.
