Cross-Party Group Applications

Introduction

- 1. In accordance with the provisions on Cross-Party Groups (CPGs) set out in section 6 of the Code of Conduct (the Code), proposals for the establishment of CPGs in the Scottish Parliament must be submitted to the Standards, Procedures and Public Appointments Committee (the Committee) for its approval.
- 2. There are two proposed Groups for the Committee's consideration.

Proposed CPG on Gardening and Horticulture

3. The registration form submitted by the proposed Group is attached at Annexe A to this note.

Consideration by the Standards, Procedures and Public Appointments Committee

4. Paragraph 18 of Section 6 of the Code states "...one of the proposed Group's MSP office bearers (usually the Convener) will be invited to attend a meeting of the Committee to explain the justification for the proposed Group." Rachael Hamilton MSP has been invited to the meeting to discuss registration of the proposed Group.

Purpose

- 5. Paragraph 19 Section 6 of the Code states "the Committee will pay particular attention to a proposed Group's purpose. If the Committee considers that a proposed Group is not in the public interest but is intended, for example, to further particular commercial interests, the Group will not be accorded recognition. The Committee will also consider whether the purpose of a proposed Group overlaps the purpose of an existing Group. If there is any overlap Groups are asked to provide justification as to why their aims could not effectively be achieved within an existing Group".
- 6. The stated purpose of the proposed Group is—
 - To promote and facilitate an understanding between representatives of the world of gardening and horticulture with members of the Scottish Parliament

7. The Group does not consider its purpose overlaps with any other existing Group.

Membership

- 8. Paragraph 8 of Section 6 of the Code requires group membership to include at least five MSPs, with at least one MSP from each of the parties or groups represented on the Parliamentary Bureau. The Committee has previously agreed that there should be a general waiver of this Rule in the current Session and Groups are now required to have five MSPs from the majority of parties represented on the Parliamentary Bureau. The proposed Group meets this requirement.
- 9. The MSP membership (by party) of the proposed Group is as follows—
 - Three Scottish Conservative and Unionist Party
 - One Scottish Labour Party
 - Two Scottish National Party
- 10. Paragraph 9 of Section 6 of the Code entitles groups to contain members from outwith the Parliament. The proposed Group has listed three non-MSP members in the individual category and 15 in non-MSP member organisations.

Office Bearers

11. Paragraph 10 of Section 6 of the Code requires one MSP to be Convener of the Group and there to be at least one other MSP office bearer. The proposed Group meets this requirement: Rachael Hamilton MSP is the Convener of the Group and Christine Grahame MSP and Alex Rowley MSP are the Deputy-Conveners.

Financial Benefits and Subscription

- 12. The registration form indicates that the Group will receive no financial benefits.
- 13. The registration form also indicates that members will not be charged a subscription.

Proposed CPG on Stroke

14. The registration form submitted by the proposed Group is attached at Annexe B to this note.

Consideration by the Standards, Procedures and Public Appointments Committee

15. Gillian Mackay MSP has been invited to the meeting to discuss registration of the proposed Group.

Purpose

- 16. The stated purpose of the proposed Group is—
 - To provide oversight, encouragement and support for the implementation of a progressive stroke service in all Health Boards, based on the recommendations in a new (2022) stroke action plan
 - Increase political awareness of the scale and impact of stroke and the benefits which implementation of a progressive stroke service will make
 - Increase political awareness that stroke is a national clinical priority and help ensure stroke is treated as a clinical priority in Health Boards
- 17. The Group does not consider its purpose overlaps with any other existing Group.

Membership

- 18. The proposed Group meets the requirement in relation to MSP membership which is as follows
 - One Scottish Conservative and Unionist Party
 - One Scottish Green Party
 - Two Scottish Labour Party
 - Two Scottish National Party.
- 19. The proposed Group has listed no non-MSP members in the individual category and one in non-MSP member organisations. The Group is intending on inviting a number of external organisations to be members but have not formally approached ay as yet. The Group intends to update the membership when external bodies join.

Office Bearers

20. The proposed Group meets the requirement in relation to office bearers: Gillian Mackay MSP is the Convener of the proposed Group and Paul O'Kane MSP is the Deputy-Convener.

Financial Benefits and Subscription

- 21. The registration form indicates that the proposed Group will receive the following financial benefits—
 - As majority of meetings will be held virtually via either Zoom or MS Teams
 we do not anticipate any catering or additional costs however if there are
 any costs then they will be covered by the Stroke Association.

- Secretariat support is estimated to comprise approximately 5 days of work for each meeting of the Cross-Party Group at an approximate value of £80 per day. Assuming the CPG convenes for the intended 4 meetings during a 12-month period, financial benefits received are therefore estimated at £1,600.
- 22. The form also indicates that members of the Group will be not be charged a subscription.
