# Correspondence relating to accessing court transcripts

# **Background**

- 1. Members will recall that the Committee has been scrutinising the case for improving access for survivors of rape and sexual offences to the transcripts of their court cases. Specifically, the Committee has been looking at the current costing regime associated with requests to the Scottish Courts and Tribunals Service. This issue was first raised with the Committee in December 2021 by one of the survivors that Members met informally to hear about their experience of the criminal justice system. The Committee would like to thank her for raising this important issue.

- 3. The Committee has now received additional correspondence from (see **Annex**):
  - The Cabinet Secretary for Justice and Home Affairs.
  - Rape Crisis Scotland (RCS) on behalf of several survivors who took part in a survey about their experiences.
- 4. This correspondence relates to the pilot proposed by the Scottish Government to enable survivors of rape and sexual offences to have access to the transcripts of their court cases.
- 5. Members may wish to note that the Cabinet Secretary for Justice and Home Affairs has confirmed her support for the Committee's proposal for a pilot scheme in her recent letter, stating she is "committed to exploring a pilot to support access to transcripts for complainers in sexual offences cases, initially".
- 6. Additionally, the First Minister gave a commitment to a pilot focused initially in relation to complainers in sexual offence cases, when he answered a question on this issue from the Convener of the Criminal Justice Committee at the meeting of the Conveners' Group on Wednesday, 24 May 2023.
- 7. Members may wish to note some of the comments made by the survivors of rape and sexual offences in the survey undertaken by RCS, namely:

"My trial experience was incredibly traumatic and I continue to find it difficult to rationalise much of what occurred on the day. I struggle to remember much of this experience despite having lived through it. Having access to the transcript would help me to better understand my own lived experience and would further aid in my complaints process against the defence."

"I would [have] liked to have put pieces of the complex puzzle of my case together, however on initial research, it seemed cost prohibitive, so I have not attempted to access them."

"Even though there was a guilty verdict, I feel more bruised than the sexual assault. My voice was lost in the trial. There was the butterfly effect of my abuser planting seeds of doubt in the juries minds which resulted in a lot of deletions to the charge. I feel like a part of me is still seeking justice which obtaining the transcript will provide."

"So frustrated at the process of complaints procedures through PCFS which doesn't say immediately there will be no transcript access, lead you down a merry dance knowing that they will not be giving any access to transcripts even to look at the complaint. Makes no sense at all, if there is a complaint about what happened in court and the transcript can show exactly what is said and can't be used."

"I was told it would cost £2000+ which I couldn't afford."

### Scottish Government (22 May)

Dear Convener

Thank you for your correspondence dated 20 April 2023 regarding court transcripts.

At the outset, I wish to express my thanks to the Justice Committee for their continued efforts to improve the experience of the criminal justice system for victims of sexual offences. This is a priority outcome which is shared with the Scottish Government. To that end, I look forward to working with the Committee both on the issue of court transcripts but also as we progress the Victims, Witnesses, and Justice Reform (Scotland) Bill through Parliament.

In respect of the specific issue around access to court transcripts, I share the views of my predecessor that any solution on access to court transcripts should be advanced alongside our wider efforts for a person centred, trauma informed justice system.

Against that background, consideration of action in response to the particular concerns of rape and sexual assault complainers around access to transcripts should be viewed as complementary to the action being taken through the aforementioned Bill to improve the experience of women, in particular. As you are aware, the Bill has a particular focus on how sexual offence cases are managed, informed by Lady Dorrian's cross-sector Review to ensure that women are supported to have trust and confidence that our justice system will serve their needs, allow them to give their best evidence and support them in their recovery.

I would like to assure the Committee that I am committed to exploring a pilot to support access to transcripts for complainers in sexual offences cases, initially. However, consideration of the detail of any pilot is still at the very early stages and initial discussions with the SCTS are taking place to inform this consideration.

The Scottish Government welcomes the Committee's continued interest in this matter and as has been indicated in previous correspondence, we will, of course, keep the Committee updated when our consideration is at a more advanced stage.
