# **Cross-Party Groups – annual monitoring report**

# Introduction

1. The Standards, Procedures and Public Appointments Committee (the Committee) is responsible for overseeing the Cross-Party Group (CPG) system. As part of this role, it considers annual monitoring reports on Groups' compliance with the rules in Section 6 of the Code of Conduct for MSPs (the Code). The data in this report reflects the position as of 10 January 2025.

2. As of 10 January 2025, there were 119 CPGs which had been accorded recognition. During 2024 two CPGs were accorded recognition. These are:

- Brain Tumours
- Scottish Games Ecosystem.

3. Two CPGs – on Mental Health and on Nordic Countries – chose to wind-up in 2024. The CPG on Mental Health wound up following a request from the MSP office bearers and the CPG on Nordic Countries disbanded due to non-availability of MSP Members.

4. The Committee also agreed to a request from the CPG on Drug and Alcohol Misuse to change its name to the CPG on Substance Use.

5. The Committee considered three complaints about CPGs in 2024:

- Cross-Party Group on Drug and Alcohol Misuse. The Committee found that a breach of Section 6 of the Code of Conduct in respect of the accuracy of minutes of meetings had occurred.
- Cross-Party Group on Commercial Sexual Exploitation. The Committee found that breaches of Section 6 of the Code of Conduct had occurred in respect of the failure to submit an Annual Return and to provide advance notification of a meeting to the timescales set out in the Code.
- Cross-Party Group on Human Trafficking. The Committee found that a breach of Section 6 of the Code of Conduct had occurred in respect of the failure to submit the minute of the meeting held on 6 September 2022.

6. The Committee wrote to each of the CPGs about which complaints had been received noting that:

"The Committee agreed not to impose sanctions on this occasion. However, the Committee highlights that it takes compliance with the Code of Conduct by Cross-Party Groups very seriously. It recognises the important role that CPGs play in connecting MSPs with the stakeholders who have interest in and experience of issues considered by the Group. Should any further instances of non-compliance with the Code of Conduct occur, this may result in the Committee withdrawing recognition for this CPG."

# Compliance

7. CPGs are required to meet a number of rules in order to operate in compliance with the terms of the Code. In relation to membership and leadership, CPGs are required to have at least five MSP members, with at least one MSP from each of the parties or groups represented on the Parliamentary Bureau. This requirement can be modified or waived by the Committee either for individual CPGs or in general. In this Session, the Committee has agreed a general waiver and CPGs are required to have five MSPs from the majority of parties represented on the Parliamentary Bureau In relation to leadership, at least 2 MSP members of a CPG must be office bearers and one of these must be the Convener. The Convener of each CPG is primarily responsible for ensuring that the Group complies with the Code. The Code also states "all other MSP members, and any secretariat, should also ensure that they are aware of the requirements in order to assist with the efficient operation of the Group."

8. In respect of meetings and reporting, each CPG must:

- hold at least two formal (i.e. with at least 2 MPS members of the CPG present) meetings per year, one of which must be the AGM
- hold an AGM within 11-13 months of its initial meeting, and each 11-13 months thereafter
- submit an Annual Return within 30 calendar days of the AGM;
- provide Standards Clerks with 10 calendar days' notice of all meetings; and
- provide minutes of all meetings (there is no timeframe in the Code within which minutes must be provided).
- 9. Annexe A gives a summary of CPGs compliance with the Code of Conduct Rules.

10. Annexe B gives further information on those Groups that have not complied with the rules.

# **Committee consideration**

11. Having considered the information on compliance and membership, the Committee is invited to consider whether it wishes to take any action in relation to non-compliant groups and/or Groups who have failed to meet or hold an AGM. The Committee could, for example decide to write to the Conveners of Groups for an explanation, invite them in to give evidence to the Committee or remove recognition from CPGs who have consistently failed to comply with the rules.

# Further information on compliance with the code of conduct

# CPGs that have fully complied with the Code

1. 57 of the CPGs in operation during 2024 have fully complied with the Code in the relevant period. This is an overall compliance rate of 47%. A number of CPGs have been non-compliant with one or more rule going back to the 2022/23 reporting year.

# CPGs that have failed to comply with the rules most or all of the time

2. There are 18 Groups that have failed to comply with the Code most or all of the time during 2024 in at least 3 out of the 6 elements included in the table at Annex A. This equates to approximately 15% of the total number of CPGs. Of these 18 Groups, 8 have been non-compliant in all elements other than cross-party membership and 2 have been wholly non-compliant.

# **CPGs** which have partly complied with the rules

#### Insufficient MSP members and insufficient office bearers

3. Section 6, paragraph 8 of the Code requires that each Group has at least 5 MSP members, with at least one MSP member from each of the parties or groups represented on the Parliamentary Bureau. The SPPA Committee agreed a waiver to

this rule for Session 6 and all CPGs are required to have at least 5 MSP members, with at least one MSP member from the three of the parties or groups represented on the Parliamentary Bureau.

- 4. A number of CPGs at present have not met the above criteria.
- 5. The following table shows those CPGs that are not compliant regarding MSP Membership and/or Office-Bearer roles—

#### Failure to provide minutes of meetings

10. Those CPGs that did not provide minutes of meetings are highlighted in the table at Annex A

#### Failure to provide information in required templates

- 11. The Scottish Parliament must comply with strict accessibility standards for all material that it publishes online. As a result, agendas, minutes and AGM returns must be submitted using the templates provided by the Clerks. Despite this, Clerks have seen an increase in the number of non-conforming documents being sent for publishing.
- 12. CPGs such as Arthritis and Musculoskeletal Conditions, Aviation, Co-Operatives, Carers, Freedom of Religion and Belief, Taiwan and Palestine are amongst those who have repeatedly sent updates while not using the correct templates.

### **CPGs at risk**

- 13. Whilst compiling this report, Clerks observed that the following CPGs are at risk of breaching Section 6 of the Code of Conduct should relevant action not be taken soon.
- 14. The CPG on Care Leavers AGM is due to be held on 21/2/25. At the time of this report, no date had been set.
- 15. The CPG on Brain Tumours AGM is due 29/4/25. No meetings have been held since the CPG was accorded recognition in April 2024.
- 16. The CPG on Islands AGM is due on 5/2/25. At the time of this report, no date had been set.
- 17. The CPG on Palestine AGM is due on 7/2/25. At the time of this report, no date had been set.
- 18. The CPG on Stroke AGM is due on 19/1/25. At the time of this report, no date had been set.

#### Examples of repeated non-compliance

19. The Committee may also wish to note the following examples of Groups that have been non-compliant with at least one of the rules in previous years and which are

again non-compliant with at least one rule in this reporting year. These examples are not exhaustive but are provided to assist the Committee in considering issues of compliance in the round.

- 20. The CPG Germany was highlighted in the 2023/24 report for non-compliance for submitting an annual return on time and minutes of meetings. This report, it is highlighted again for not providing minutes of meetings and notification of meetings.
- 21. The CPG on Lung Health is being highlighted due to issues with MSP membership. In September 2023, the CPG only had four MSP members. In January 2024 Clerks were informed by the CPG that Jackie Dunbar MSP had joined the CPG thus making the CPG complaint again. In June 2024 Jackie Dunbar MSP emailed to request her removal from the CPG stating she was never a member of it hence the reason for highlighting this CPG. Membership issues were subsequently sorted at the AGM in June 2024.
- 22. The CPG on Nuclear Disarmament was highlighted in the 2023/24 report for having a late AGM. It has also held a late AGM in 2024 and is in breach for provision of minutes of meetings (only 1 minute of 6 meetings received).
- 23. The CPG on Older People, Age and Ageing has highlighted in the 2023/24 report for holding a late AGM. It is now being highlighted in the 2024/25 report for holding an AGM too early.
- 24. The CPG Social Enterprise was highlighted in the 2023/24 report for MSP membership issues. It is being highlighted in this report for no AGM meeting or return.
- 25. The CPG Wood Panel Industry was highlighted in the 2023/24 report for failure to provide minutes of meetings. It is being highlighted in this report for failure to notify Clerks of meetings within required timeframe and for not providing minutes of meetings.
